Pomegranates – new standard



- Proposal to develop standard based on Codex standard
- Need no legal basis for labeling size and class for pomegranates
- No UNECE standard
- Aligned with standard layout of UNECE Standards for FFV
- Standard contained in ECE/CTCS/WP.7/2021/28 for approval and adoption by WP.7

Carrots



Minimum requirements:

- deleted "i.e. sufficiently dried after washing".
- added "In case of carrots with leaves, these must be sound, fresh and clean. The foliage may be trimmed".

Extra Class & Class 1

deleted "If presented with leaves, leaves must be fresh in appearance".

Class 2

- added "In case of carrots with leaves, the foliage may be slightly discoloured."
- added "some secondary roots"
- added "In case of carrots with leaves, the foliage may show some discolouration".
- amended "forked" to allow one fork with two tips clarity

Strawberries



Minimum requirements

Requirement for "green" in relation to the calyx was deleted

Classes 1 & 2

added "dried calyx, provided the fruit is fresh and sound".

Fresh Figs



Provisions concerning sizing

Size is determined by the maximum diameter of the equatorial section or by count. The minimum size shall be 40 mm.

- (a) To ensure uniformity in size, the range in size between produce in the same package shall not exceed:
 - 5 mm for fruit packed in rows and layers
 - 10 mm for fruit loose packed in the package.
- (b) For fruit sized by count, the difference in size should be consistent with (a)s.

Added or number of fruit.

Chinese cabbage



Minimum requirements

deleted "free from freezing damage"

Class 1

deleted "well formed"

Cucumbers



- Provisions concerning sizing
 - substituted "piece" with "cucumber"
- Provisions concerning marking

Commercial specifications

 added "or number of cucumbers or mini-cucumbers, in case of cucumbers below 180g"

Watermelons



Classification

Class 1

Deletion - slight skin defects due to rubbing or handling, of which the total area affected must not exceed one sixteenth of the surface of the fruit.

Class 2

Substituted - This class includes watermelons that do not qualify for inclusion in Class
 1 but satisfy the minimum requirements specified above."

with

- "This class includes watermelons that do not qualify for inclusion in the higher classes but satisfy the minimum requirements specified above."
- Deletion skin defects due to rubbing or handling or to damage by pests or diseases,
 of which the total area affected must not exceed one eighth of the surface of the fruit

Apricots



Quality tolerances for Class 2

 Within this the 10 per cent tolerance, fruit split at the stalk cavity and fruit with split stones are allowed.

Cauliflower



Minimum requirements

- intact; however, cauliflower may be presented "with leaves", "without leaves", or "trimmed" provided they comply to the following provisions:
 - "trimmed": cauliflower with a sufficient number of leaves left on to protect the head. These leaves must be healthy and green and may be trimmed to not more than 3cm from the top of the head. The stem must be cut off slightly below the protecting leaves.

Standard Layout



IV Provisions concerning tolerances - Foot note added:

- At all marketing stages, tolerances in respect of quality and size shall be allowed in each lot for produce not satisfying the requirements of the class indicated³.
- A conformity check shall be made by assessing primary or composite samples. It is based on the principle of presumption that the quality of the randomly taken samples is representative of the quality of the lot. The application of the OECD Operating Rules for Conformity

 Checks are recommended for application also by operators at the stages of dispatch as well as in wholesale and distribution centres of food retail. http://www.oecd.org/agriculture/fruit-vegetables/publications/oecd-fruit-and-vegetables-rules.htm

VI Provisions concerning marking

These marking provisions do not apply to sales packages presented in packages bearing these
particulars. However, they do apply to sales packages (pre-packages) presented individually.
