- Identify needs, key bottlenecks and opportunities for market conditions and possible investment promotion



REN21 UNECE Renewable Energy Status Report 2017 (June) in the 17 countries: Overall


- Report 2017 shows a slowdown in RE investment flow
- USD 700 million in 2014, global share of 0.5%
- USD 400 million in 2015, less than 0.2% of the global total
- The lack of investment as key barrier to accelerate modernization of energy infrastructure and improve the quality of life.

Hard Talks: An Innovative Policy Dialogue Tool For Unblocking Renewable Energy Barriers to Investment

- A uniquely formatted multi-stakeholder dialogue:
 - Involved Ministries Energy, Economy, Finance, etc. Other key players – RES Agencies, Regulators, Network operators Private sector – project developers, industry associations Parliament, NGOs, media (2nd day) Financial actors – IFIs, development banks and commercial lenders
- Adapted to the specifications and requirements of the host country;

International community – Donors, Consulates, etc.

- Discussion guided by a practical "problem/solution" Discussion Paper;
- **Neutral international facilitators** for the dialogue
- Involves two days to deliver key messages from experts and main stakeholders through specific Recommendations, prioritizing the next steps that are sent to all participants and high-level decision-makers for further action
