 broader and deeper engagement, ranging from capacity development to science and technology, to non-routine verification activities, to the global fight against terrorism.




# 2021 Activities Towards Prevention of Chemical Accidents

IACG members can take part as experts, where appropriate








## Indicative Guidelines for Chemical Safety and Security in SME to Foster the Peaceful Uses of Chemistry

- Launched on 29 June 2021






### **CWC States Parties have been adopting regulatory measures covering the entire life-cycle of chemicals**

Legislative and administrative measures:

- cover the areas of concern based on identified risks
- vary among SPs, depending on the size of its chemical industry and chemical trade
