

Proposed format and main elements

Mandate to develop the MIPAA/RIS+20 report

At the 13th meeting of SWGA:

- “SWGA members expressed support though not unanimous for preparing a MIPAA/RIS +20 report – analytical, short and future-oriented – as a background document for the conference deliberations.”
- Decision was taken that the “Secretariat will support preparation of the MIPAA/RIS+20 report.”

Proposed format

- Celebratory overview of the last 20 years of MIPAA/RIS
- “Short, analytical and forward-looking”
- Around 20-30 pages
- Appealing visuals (graphs, infographs, layout)

Suggested elements

1. Most important megatrends affecting ageing in the last 20 years in the UNECE region

- Analysis of demographic, technological, socio-economic changes and developments relevant to ageing since the adoption of MIPAA/RIS in 2002

2. Progress in implementing MIPAA/RIS and the 2017 Lisbon Ministerial Declaration

- Overview of shifting perspectives on ageing in the past 20 years, complemented by interviews with time witnesses
- Mapping of national policies on ageing over time
- Key messages extracted from national MIPAA/RIS review reports

3. Outlook and way forward

- Emerging challenges, current/new trends and the way forward
