



























The Central Asian region has the capacity to produce and market sustainable high-quality walnuts, as well as fresh and dried fruit and vegetable products, for both domestic and international markets. In parallel to these opportunities, challenges remain including production methods, the tree stock, the marketing practices, the use of standardized classifications or the diversification from traditional markets and their requirements, to the search for new markets.

The agricultural sector holds high socio-economic importance and key in building viable and sustainable food systems in the region. The potential and key role of this sector for the Central Asian region is exemplified by the significant labour resources it involves and its part in economic development, and income generation for the countries and their population, particularly for the livelihoods of many local communities.

The walnut industry in the region, along with many fresh and dried fruit and vegetable products, is mainly export-oriented and, therefore, holds the potential to address and contribute to improve many of the region's socioeconomic problems. For potential to become reality, though, several key components need to be addressed one of them being the regulatory legislative and environment the understanding of markets and buyers. This includes the use of national and international standards also by local producers, production methods, marketing or sales practices.

UNECE ¹ commercial marketing and quality standards are examples of widely recognized minimum requirements used in markets and the trade of nuts and dried fruit worldwide. The walnut standard for example is applied by leading producers, traders and buyers in Europe, USA or Asia in their commercial transactions and by their quality inspection bodies.

Walnuts in Central Asia

The walnut production in many Central Asian countries is unique – in its history, production, and importance for local communities. Walnuts grow mostly in their natural habitat – tens of thousands of hectares of walnut forests which span across the western and southwestern slopes of the Ferghana and Chatkal ridges. The latter are spurs of the Tien Shan mountain system and are concentrated in three forest areas: Kugart-Arslanbob, Yassin (Ferghana ridge) and Khodja-Ata (Chatkal ridge). They cover a total area of 610 thousand ha. These forests create a forest belt at altitudes ranging from 800 to 2400 meters above the sea level and are characterized by very favourable environmental conditions.

Natural walnut forests in Central Asia: 54, 500 ha

Kyrgyzstan: 45,000 ha
 Tajikistan: 8,000 ha
 Uzbekistan: 1,500 ha

Annual harvest of wild walnuts in Central Asia: 13,350 tons, including:

Kyrgyzstan: 10,000 tonsTajikistan: 3,000 tonsUzbekistan: 350 tons

Annual export of wild walnut kernels: approx. 3,500 tons.

Local communities and livelihoods

The sale of wild walnuts (in-shell and kernels) is a key source of income for over 100,000 people in the rural areas of Central Asia. The proceeds from the sale of walnuts account for up to 40% of their annual family income.

GOALS AND OBJECTIVE:

Recognizing the importance of improving the sector as part of a larger food system, the workshop will address several topics that are essential to improve the current situation. This includes the understanding, use and control of international standards, which authorities and some traders have been promoting for several years already. Participants will also hear about other aspects such as production, marketing and sales.

The workshop is supported by the project of the Austrian organization Hilfswerk International, the GIZ Project "Biodiversity Conservation and Poverty Reduction through Community-based Management of Walnut Forests and Pastures", the GIZ Regional Trade Facilitation Program in Central Asia (TFCA) and the UNDP Regional Project ": Aid for Trade in Central Asia" (funded by the Finnish government) and UNECE. The latter has been supporting the development, revision and use of standards in the international food trade in the Central Asian region for many years. The national standardization bodies of Kyrgyzstan, Tajikistan and Uzbekistan, as well as associations industry of processors, manufacturers and exporters of walnuts are promoting it.

The workshop aims to:

 Strengthen the capacity of authorities, agencies, private sector (walnut producers, traders, and exporters) in using product classification methods,

- quality control and inspection in accordance with the requirements of UNECE standards.
- 2. Outline common practice to improve the production, marketing and sales of walnut kernels.

PARTICIPANTS:

- Representatives of national state institutions: standardization bodies, ministries of economy, agriculture and other relevant sectors of the countries of the region (Kyrgyz Republic, Uzbekistan, Tajikistan)
- Experts, industry associations, manufacturers, processors and traders/exporters

The regional practical training is organized with the assistance of the Center for Standardization and Metrology the Kyrgyz Republic, Republic of Uzbekistan, Republic of Tajikistan and with the support of international organizations: Hilfswerk International; UNDP (Regional Project "Aid for Trade in Central Asia") and UNECE.
