

Evaluation of the project “Implementation of the National Water and Health Targets in the Kyrgyz Republic and Tajikistan through National Policy Dialogues” (June 2019)

1	It is recommended to consider a possibility of continuing support for promoting accession to the Protocol on Water and Health in the beneficiary countries and in Central Asia in general.	<p>UNECE accepts the recommendation.</p> <p>UNECE continues to promote accession to the Protocol on Water and Health in Tajikistan and Kyrgyzstan, as well as also in Kazakhstan and Uzbekistan, both through organization of briefings on Protocol obligations and technical activities under the programme of work. EUWI+ programme, and the National Policy Dialogues supported under its framework, provides a platform for continuous follow up. The upcoming fifth session of the Meeting of the Parties to the Protocol (Belgrade, 19-21 November 2019) will provide another opportunity to promote accession to the Protocol among all Central Asian countries.</p>	Protocol on Water and Health Secretariat	Implemented as of December 2019	<p>After the termination of the project, UNECE continued to promote accession to the Protocol by Kyrgyzstan and Tajikistan and the countries were asked to intensify their efforts, particularly in view of the fifth session of the Meeting of the Parties to the Protocol (Belgrade, 19-21 November 2019).</p> <p>At the fifth session of the Meeting of the Parties, Tajikistan reported to be in the process of accession to the Protocol and highlighted that, while not being a Party, the country had already implemented several activities under the Protocol's framework which supported national progress on water, sanitation and health. The Meeting of the Parties welcomed this statement and encouraged Tajikistan to accelerate its efforts.</p> <p>Kyrgyzstan also attended the fifth session of the Meeting of the Parties. UNECE held a bilateral meeting with the delegation, during which it promoted accession and expressed readiness to provide technical assistance and to support the country throughout the accession process, if needed.</p> <p>Kazakhstan and Uzbekistan were also present at the fifth session of the Meeting of the Parties and reported to be considering accession to the Protocol.</p> <p>UNECE held bilateral meetings with the delegations of all Central Asian countries present at the meeting, during which it promoted accession and expressed readiness to provide technical assistance and to support the countries throughout the accession process, as</p>

2	For future projects, direct involvement of senior leadership at early stages is crucial to ensure high effectiveness and achievements of planned results in time.	<p>UNECE partially accepts this recommendation.</p> <p>UNECE had involved high-level officials in both beneficiary countries from the very beginning of the project. However, political changes in the ministries or in the governments can happen at any time and are beyond UNECE control. UNECE will continue to follow the approach of facilitating involvement of senior leadership into similar projects in the future, including through the UNECE senior leadership.</p>	Protocol on Water and Health Secretariat	June 2022	<p>In progress as of 31 December 2021</p> <p>Contextual narrative: After the termination of the project, UNECE has been in contact with the donor country about the possibility of having a third phase of the project in Kyrgyzstan and Tajikistan. However, due to funding limitations, a third phase is not envisaged. Therefore, at the moment, there is no running project on water and sanitation in the beneficiary countries or in other Central Asian countries.</p> <p>In upcoming projects to be implemented in 2022, UNECE is committed to build on the experience of this project and involve senior leadership at early stages, to ensure high effectiveness and achievements of planned results in time. This is subject to the observation that political changes in the ministries or governments can happen at any time and are beyond UNECE control</p>
3	Additional awareness raising events (seminars, workshops) would be recommended to raise effectiveness of future projects in terms of shortening the time to achieve results.	<p>UNECE accepts this recommendation.</p> <p>In future similar projects UNECE will include awareness activities to improve visibility and effectiveness of the project results. However, in terms of nomination of experts for the working groups, the decision power to designate officials remains within the relevant authorities and is beyond UNECE control. 5	It is recommended to support further activities targeted to incorporation of project results into regular government programs to ensure full sustainability.	<p>UNECE accepts this recommendation.</p> <p>UNECE will continue following up on the implementation of the targets set in the context of the Protocol under the project. In addition to the accountability framework provided by the National Policy Dialogues, within the Protocol programme of work for 2020-2022, UNECE will make efforts to promote the inclusion of the targets into the national policies, strategies and programmes in both Kyrgyzstan and Tajikistan.</p>	Protocol on Water and Health Secretariat	Implemented as of December 2019	<p>See contextual narrative from recommendation 2</p> <p>At the fifth session of the Meeting of the Parties, Kyrgyzstan and Tajikistan reported on relevant developments happened since the termination of the project.</p> <p>Kyrgyzstan mentioned that the targets set under the Protocol will be used for the national long-term strategy on sustainable development. Kyrgyzstan also adopted two legal acts on wastewater treatment and wastewater collection, strengthening the sustainability of project results.</p> <p>Tajikistan reported on the development of the National Water Strategy. The Strategy identifies 30 flagship measures that will be promoted by the Tajik government and, amongst these, some are closely related to the revised targets developed under the project.</p> <p>UNECE is committed to follow-up on these and other relevant developments related to the incorporation of project results into regular</p>

The area of work under the Protocol of equitable access to water and sanitation contributes to the implementation of the human rights to safe drinking water and sanitation, including the principle of non-discrimination and equality.</p>
