Short history:

- 18.3.1992 Convention on the Transboundary Effects of Industrial Accidents agreed in Helsinki, Finland
- 9.9.1998 ratification Germany
- 12.6.2000 accession Czech Republic
- 8.9.2003 ratification Poland
- 2006 change of Annex I The Amendments were adopted at the fourth meeting of the Conference of the Parties, (in Rome) and entered into force on 19 March 2008.
- 2014 the Amendments were adopted at the eighth meeting of the Conference of the Parties, (in Geneva) and entered into force on 19 December 2015.



- Regular bi- and trilateral meetings


Information sharing:


Potentially hazardous installations less than 15 km from borders-

International training Eisenhüttenstadt



- Polish Germany border river Oder
- Multi-stakeholder training of first responders and their international cooperation
- Various scenarios: hydrocarbon spill on river, extended fire, flood, explosion...
- Wide international seminary with god practices sharing













International training Kotki

- At the border between Poland and Russia (Kaliningrad)
- Paticipation of experts from many UNECE countries
- Comlex exercise in international cooperation:
 - chemical release with transboundary effects
 - transport accident
 - terrorist attack











Common research & development and education activities



- Most of common actions in the wider platform: JEG Joint Expert Group, e.g. preparation of guidelines
- Especially Germany (UBA and other organisations) is active in international projects, seminaries and assistance programmes, e.g.:
 - Tailing facilities safety
 - Pipeline safety
 - NATECHS
 - Contingency planning
 - Others...







Regular meetings of working groups for realization of Convention

- 20 regular meetings of Germany Poland bilateral working group
- 10 regular meetings of Germany Czechia bilateral working group
- Last one (13-14 November 2018, Berlin) first trilateral working group



Programme of trilateral meeting Berlin

- Agreement on protocols of bilateral meetings (19th D-PL, 9th D-CZ)
- Information Exchange in the Convention Framework
 - Cooperation of emergency services in the borders proximity and evaluation of international exercises (e.g. Roter Eber in Chamerau, 2500 participants)
 - Communication (including translation) in international cooperation
 - Equipment compatibility
- Actualisation of contact points
- Firewater retention expert group report and training (Ratzdorf, D-PL)
- Early warning
- Accidents and lessons learned:
 - Świnoujście 2017
 - Litvínov 2015
 - Kralupy 2018







Conclusions:

- UNECE Convention on the Transboundary Effects of Industrial Accidents is a Framework and an integral part of both national and international effort of trilateral CZ – D – PL working group
- Exchanging information and understanding good practices allow to consider new and innovative approaches to strengthening their implementation
- Acivities of Trilateral Working Group commonly cover UNECE Convention on the Transboundary Effects of Industrial Accidents, Sendai Framework, EU legislation and OECD recommendation
- Further development of exchanges and activities is envisaged
