#### 3. Submissions, referrals and communications


The Committee took note of the report by the secretariat informing the Committee that there were no submissions, referrals and communications since the Committee's latest meeting.

# 4. National pollutant release and transfer registers in the European Union member States

The Committee:

- Expressed its appreciation to Finland for the constructive cooperation on the
- Concluded that, by establishing "FINPRTR", Finland addressed major issues provided in the Committee's advice;
- Noted that the work on improving "FINPRTR" is ongoing and invited Finland
  to provide the Committee with further update once the remaining planned
  measures are implemented, notably by 1 February of 2023, 2024 and 2025. In
  addition, the Committee agreed to cease its work on draft findings on the subject
  matter;
- Based on information received through the 2021 reporting cycle and para 15 of the synthesis report, the Committee decided to send similar (as to Finland) initial
