### **3. Identification of stations on the AGC network to be defined as an international passenger railway hub**

The Group of Experts will be invited to continue discussions on the identification of the hubs based on documents ECE/TRANS/SC.2/HUBS/2022/3 and ECE/TRANS/SC.2/HUBS/2021/8 prepared by the secretariat in collaboration with experts, setting out proposals for a definition of international passenger railway hubs, a criteria for the identification of such hubs, an initial list of potential stations to be classified as these hubs and comments received from experts.

### **4. Identification of the technical and service parameters necessary for the definition of an international passenger railway hub**

The Group of Experts will be invited to continue discussions, in line with the approach of Annex III of the AGC and with Annexes III and IV of the AGTC, on what principles should be defined as minimum requirements for international passenger railway hubs. Discussions will be supported by ECE/TRANS/SC.2/HUBS/2022/4 and ECE/TRANS/SC.2/HUBS/2021/9 prepared by the secretariat in collaboration with experts, continuing the work on the technical and service parameters.

### **5. Identification of the legal instrument or tool to be used for international railway passenger hub and draft the necessary legal provisions**

The Group may wish to consider document ECE/TRANS/SC.2/HUBS/2022/5 as an input to these discussions.
