It is strongly recommend either include a separate chapter on the status of "Biodiversity" or combining this chapter to read "Biodiversity and Ecosystems" as it is the case in the assessment draft (cf. page 89). As it stands, albeit the fact that this chapter is dedicated to the status of ecosystems in general, its recommendations section deals almost entirely on measures to combat biodiversity loss (see extraction below). The recommendations will thus best fit to a dedicated chapter on biodiversity rather than solely on ecosystems.
