

II. Annotations to the provisional agenda

1. Opening of the meeting and adoption of the agenda

Timing: Monday, 30 May, 10-10.10 a.m.

1. The United Nations Economic Commission for Europe (ECE) Steering Committee on Education for Sustainable Development (ESD) is expected to adopt the agenda for its seventeenth meeting as set out in the present document. The draft agenda was prepared by the secretariat and the Chair of the Committee.¹

2. Implementation of the United Nations Economic Commission for Europe Strategy for Education for Sustainable Development

(a) Progress in implementing the Strategy

Timing: Monday, 30 May, 10.10-11 a.m.

- 2. To facilitate tracking progress in the implementation of the Strategy since the submission of the national implementation reports for the fourth mandatory reporting cycle carried out in 2018, a questionnaire (ECE/CEP/AC.13/2022/5) will be sent to countries prior to the seventeenth meeting. Countries will be invited to return the completed questionnaires, which will serve as informal reports on implementation, to the secretariat by no later than 15 April 2022.
- 3. At the meeting, the secretariat will provide a brief synopsis of the progress made and the experiences of ECE member States in the implementation of the Strategy based on an analysis of the informal questionnaires submitted by countries.
- 4. In the questionnaire, particular attention will be paid to the main priority strands of the Strategy's new implementation framework (2021–2030) (ECE/CEP/AC.13/2022/3), focused on: quality education and ESD; whole institution approach and ESD; digital education, information and communications technology and ESD; entrepreneurship, employability, innovation and ESD; and youth and ESD.
- 5. Countries will be invited to complement the secretariat's presentation with interventions on outstanding activities and initiatives implemented since the sixteenth Steering Committee meeting (Geneva, 10–11 May 2021), in particular with regard to how the implementation of national strategies for ESD contributes to the new developments and challenges for ESD in the region, taking into consideration the four key strands of the new implementation framework 2021–2030 and the role of youth in ESD. Given the limited time available, countries will have a maximum of three minutes each for interventions from the floor.

- 32. The Steering Committee will be informed about the participation in the Eleventh World Environmental Education Congress "Building Bridges in Times of Climate Urgency" (Prague, 14–18 March 2022) and outcomes of the round table organized by the ECE Steering Committee on Education for Sustainable Development in the framework of the Congress, in cooperation with the United Nations Environment Programme (UNEP) and UNESCO.
- 33. The Steering Committee will be also updated on recent activities held under the aegis of UNEP, the European Commission, the Mediterranean Strategy on Education for Sustainable Development, the Global Education Network Europe, the Framework Convention on the Protection and Sustainable Development of the Carpathians, and others.

- 40. The secretariat will report to the Steering Committee on contributions received since the Committee's previous meeting, on the basis of an informal note (information paper No. 6) to be submitted for the Committee's consideration at the meeting. Since the funding situation of the Strategy for ESD is always very tight, and the regional activities are funded exclusively through contributions by member States to the trust fund, advance indications of pledges by States are vital.
- 41. The Chair of the Steering Committee will invite the members of the Committee and national focal points to consider the funding situation regarding the Strategy's activities over the previous several years, with a view to examining alternative ways of addressing the matter, including providing in-kind contributions to various programme activities.
- 42. The Steering Committee will be invited to discuss the funding perspectives of capacity-building activities for the next decade based on the outcomes of the survey considered under agenda item 2 (c) and taking into consideration the priorities of the newly drafted implementation framework.
- 43. During the discussion, the Steering Committee will be expected to look for ways to mobilize additional funds for capacity-building activities at the national and subregional levels.

(b) Establishment of a successor project: matters for the decision of the United Nations Economic Commission for Europe Executive Committee

- 44. The Steering Committee will be updated about the status of extrabudgetary technical cooperation project E285 "Strengthening the capacity of UNECE member States in implementation of the UNECE Strategy for Education on Sustainable Development", which was originally scheduled to run to the end of 2021 but was exceptionally extended until 30 June 2022.
- 45. The Committee will be invited to ask the secretariat to undertake the necessary steps for the extension of project E285, or to create a successor project with the required administrative procedures, including the opening of a new account subject to approval by the Executive Committee.

(c) Voluntary scheme of contributions

Timing: Tuesday, 31 May, 4.20-4.30 p.m.

46. The Steering Committee will be invited to discuss the possibility of revising a voluntary scheme of contributions that was proposed in the 2005 Vilnius Framework for the Implementation of the UNECE Strategy for Education for Sustainable Development with the aim of ensuring the availability of stable and predictable sources of funding for the effective implementation of the Strategy. The then-proposed scheme of contributions referred to the

following indicative amounts of contributions: for "big" donors - \in 20,000 or more; for "medium" donors - \in 2,000 or more; and for "small" donors - \in 200 or more.

- 47. The secretariat will inform the Committee that, currently, the administrative costs for receiving a contribution from a member State (that entails charges for setting up the pledge and then applying the cash received) exceed the amount of the initially approved minimum threshold, which makes it inefficient and even negative for the trust fund.
- 48. The Committee may consider recommending the minimum indicative amount of voluntary contribution.

49. The Steering Committee will be invited to discuss the format and timing of the eighteenth Steering Committee meeting, to be held in 2023, as well as of the next eventual meetings of the working groups of experts (ad hoc groups).
