### **Policy Dialogue:**

"Unlocking the Potential of Procurement and Public-Private Partnerships to Boost the Innovation Needed for the 2030 Agenda and the Circular Economy Transition"

As the latest report of the UN Secretary General shows [1], the world is not on track to meet the Sustainable Development Goals by 2030. In fact, the COVID-19 pandemic has further delayed the transition to an environmentally sustainable, socially inclusive and prosperous world.

To get back on track, the Secretary General's report inter alia calls for "strengthening [...] public services (including health systems, education, water, sanitation and other basic services); increasing investment in science, technology and innovation; [...] taking a green-economy approach and investing in clean energy and industry". In fact, in the UNECE region, the data show that progress on innovation needs to be accelerated, and that on infrastructure, the trend even points in the wrong direction. [2]

The policy dialogue will discuss how Governments can address the above challenges. It will focus on one particular policy tool, public procurement, which is a large demand lever. It has tremendous underused potential to accelerate sustainable development, including in the areas of the circular economy transition and digital transformation. [3]

### High-level Panel 10:30-12:00 CEST

Public procurement spending is large in the UNECE region, reaching up to 20 percent relative to GDP in some countries. At the same time, the fiscal strain imposed by the COVID-19 pandemic has made obtaining the best possible value for money even more important, especially in UNECE member States with economies in transition.

The high-level panel will frame the discussion and explore strategic opportunities and challenges for public procurement to promote innovation and sustainable infrastructure, and thereby help achieve the goals of the 2030 Agenda, including on digitization, the circular economy transition, and greening the economy in the UNECE region.

### Panel 1:

Green and Sustainable PPP Procurement **15:00-17:00 CEST**  Long-term privately financed and integrated contracts is what distinguishes PPP procurement from traditional public procurement. This distinctive feature provides a greater scope for governments to promote and implement greener and more sustainable outcomes compared to traditional contracting.

The challenge is to ensure that governments are implementing the right policies and use adequate instruments to promote sustainable practices along the three PPP procurement stages: (1) procurement planning (including needs assessment); (2) procurement process (including bidding, bid evaluation and contract award); and (3) procurement implementation (including contract management).

This session will consider how best to meet these challenges in the UNECE region.

#### **Discussion starters**

- What are the green procurement practices that can be promoted and implemented along the three PPP procurement stages?
- How are these practices impacting, if any, the whole life cycle costs?
- What about the bankability of innovative projects?
- What are the recommended public policy actions for Governments to ensure that PPP procurement becomes more sustainable and circular?

### Panel 2: The Role of

Procurement in Boosting Innovation for Sustainable Development 10:00-12:00 CEST Businesses often cite a lack of demand for innovative products or services as a major reason for not investing more in R&D and innovation. This holds particularly for the circular economy transition and sustainable development because these require systemic shifts in production and consumption patterns, i.e what might be called transformative innovation.

Public procurement can be a powerful policy lever to stimulate this demand and to catalyse experimentation with new disruptive ideas and technologies that set our societies on a sustainable path. There are many examples of technologies originally developed in response to government contracts that became the basis for large new industries and millions of new jobs, including the internet, GPS, and platform technologies.

To successfully mainstream innovation, sustainability and circularity into procurement practices, Governments need to set the right incentives, manage the associated risks, improve the skills and capacity of public procurement officials, and enhance data collection and monitor results. It is also crucially important to create new forms of partnerships and coordination with the private sector.
