#### Implementation of Art. 9(3)+(4) incomplete

Consistent evidence of barriers in EU MS - most recent:


- 2019 IEEP & Milieu Studies;
- 2019 EIR Communication, p. 7;
- See also 2021 e-justice fiches

E.g.: ""broad legal standing is granted by law and in practice in less than half of the Member States (13 out of [back then] 28)"



## Main barriers requiring legislative intervention

- Lack of standing / restrictions to scope of review
- Prohibitive costs
- Insufficient standard of review




### An urgent need for action

- Access to justice = human right

(Art. 47 EU Charter, Art. 6 and 13 ECHR) + right to healthy environment (Art. 1 Aarhus Convention) etc

- Crucial for better implementation and enforcement

E.g.: create 400,000 jobs and additional annual turnover of EUR 42 billion if EU waste policy is implemented (2019 EIR)



#### European Commission Priority Areas

- MS to ensure correct transposition of EU secondary law;
- 2. EU co-legislators to include provisions on access to justice in EU legislative proposals concerning environmental matters;
- 3. MS to review their national legislative and regulatory provisions
- 4. National courts to guarantee the right to an effective remedy



#### Zoom in on Priority 2: Inserting A2J provisions under EU law

- Failed / insufficient attempts:
  - Horizontal Directive (COM/2003/624)
  - Art. 12 <u>Single Use Plastics Directive</u>; Art. 16 <u>Drinking Water Directive</u> & Art. 12 <u>Water Reuse Regulation</u> proposals
  - Statement on the EU Climate Law
  - = Insufficient to ensure A2J on the ground



#### Zoom in on Priority 2: Inserting A2J provisions under EU law

- Many opportunities:

- Current: Art. 30 Deforestation Proposal;
- Upcoming: Effort Sharing Regulation, Restoration Law, Air Quality Directive, Chemicals (REACH), Food Systems Law
