14.	13	Following the successful workshop held during the GRPE week on 31 May, GRPE agreed to add life cycle assessment to the list of priorities of GRPE and to create a new Informal Working Group on the topic. GRPE agreed the new IWG on LCA will meet in the fall. Japan agreed to host the hybrid meeting, where ToRs and leadership team will be discussed.
