Ratification status of the Water Convention, its amendments and Protocols

Note by the secretariat

1. The present document sets out the ratification status of the 1992 Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention), the amendments to its articles 25 and 26, as well as its Protocols, as of 15 June 2022.

2. 45 countries and the European Union were Parties to the Water Convention, adopted in 1992. The Water Convention entered into force on 6 October 1996. Guinea Bissau and Togo are the most recent Parties to the Water Convention and acceded respectively on 14 June 2021 and 28 September 2021.

3. 45 countries and the European Union approved, accepted or acceded to the amendments to articles 25 and 26 of the Water Convention, adopted in 2003. The amendments entered into force on 6 February 2013 and became operational on 1 March 2016.

4. The Protocol on Water and Health to the Water Convention, adopted in 1999, was signed by 36 countries and ratified, acceded, accepted or approved by 27 Parties. The Protocol entered into force on 4 August 2005. Montenegro is the most recent Party to the Protocol on Water and Health and acceded on 22 November 2019.

5. The Protocol on Civil Liability and Compensation for Damage Caused by the Transboundary Effects of Industrial Accidents on Transboundary Waters to the Water Convention and to the 1992 Convention on the Transboundary Effects of Industrial Accidents was signed in Kiev in 2003 and has not yet entered into force. As of 7 June 2022, 24 countries signed the Protocol and one country (Hungary) had ratified it (25 June 2004).

6. 37 countries are Parties to the 1997 Convention on the Law of the Non-Navigational Uses of International Watercourses (Watercourses Convention), adopted in 1997. The Convention entered into force on 17 August 2014. Ghana is the most recent Party to the Watercourses Convention and acceded on 22 June 2020.
