Objective: Identify and discuss technology and policy options for policymakers to design and create resilient energy systems in the United Nations Economic Commission for Europe (UNECE) region and how the Committee can best support these efforts

Context:

The UNECE region is facing a number of economic, geopolitical, supply chain, and environmental challenges that pose significant risks to the current regional energy systems, exposing its vulnerabilities. This is alarming as all these challenges may divert policymakers' attention from the longer-term objectives of meeting the 2030 Agenda for Sustainable Development the Paris Agreement targets. It is essential to focus efforts, resources and expertise on addressing the range of crises in an integrated way, considering both the short- and long-term objectives. The current challenges provide a unique opportunity for member States to rethink the existing energy infrastructure and design more resilient energy systems that deliver on energy security, economic and climate goals.
