Dear Ms. Bouman and Ms. Duin,

I refer to your letter of 9 September 2022, in which the Netherlands sought an extension of the timeframe for it to comment on the Committee's draft advice on decision VII/8m.

I write to inform you that the Chair of the Committee has agreed to grant a six-week extension of the timeframe to comment on the draft advice. The extended deadline will be **Tuesday, 25 October 2022**.

In keeping with the Committee's practice, this extension will apply equally to communicants and observers.

In its letter of 9 September, the Netherlands also asks whether other Parties to the Convention will be invited to provide comments on the draft advice. In this regard, the Chair has requested the secretariat to notify all Parties to the Convention of the possibility to submit comments on the draft advice by the above deadline.

Following the expiry of the above deadline, the Committee will finalize its draft advice taking into account all comments received.

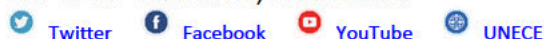
