STATUS OF RATIFICATION OF THE PROTOCOL ON WATER AND HEALTH

Note by the secretariat

Introduction

- 1. The present document sets out the ratification status of the UNECE-WHO/Europe Protocol on Water and Health to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention).
- 2. The Protocol on Water and Health was adopted for signature on 17 June 1999 and entered into force on 4 August 2005. As of 15 October 2022, 36 countries have signed the Protocol and 27 States are Parties.
- 3. On 22 November 2019, the Republic of Montenegro officially became the 27th Party to the Protocol on Water and Health.
- 4. In addition to UNECE membership, following the global opening of the Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention) to all United Nations Member States, Chad, Ghana, Guinea-Bissau, Senegal, and Togo became Parties to the Convention.
