<p>Summary: The Central Statistics Office (CSO), Ireland, published a series of Sustainable Development Goals (SDG) indicators reports. These SDG publications monitor and report on how Ireland is progressing towards meeting its targets under the 17 UN SDGs. The publications 'Ireland's UN SDGs – Goal 1 No Poverty' and 'Goal 10 Reduced Inequalities' are part of the series of SDG indicators reports. In this series SDG Goals 1 to 14 have been published to date CSO UN SDG hub. Reports for Goals 15 to 17 will be published shortly.</p> <p>The CSO and Government Departments and Organisations collaborate to bring together data required in these reports for Ireland's SDGs. This collaboration is formalised under the SDG Data Governance Board, which meets on a quarterly basis. The publication for Goal 1 was developed in collaboration with a number of Government Departments, while Goal 10 was developed in collaboration with the Department of Children, Equality, Disability, Integration and Youth.</p> <p>These publications include data for Ireland for each of the SDG indicators selected by the UN to measure 'Goal 1 No Poverty' and 'Goal 10 Reduced Inequalities'. Data is available at various levels of detail which include geography, gender, age group and other categories, where applicable.</p> <p>The reports are organised into chapters which make it easier to navigate through the data for each indicator. The titles of these chapters are based around common themes in the Targets measured in each Goal.</p> <p>Ireland's SDGs Data Hub was developed to deploy a new approach for monitoring the UN SDG Indicators using geographic information systems. Ireland's SDGs Data Hub, hosted on OSi's Geohive platform, is Ireland's Central Portal for all SDGs and contains indicators data on the 17 UN SDGs for Ireland, EU and National SDG Frameworks. All the indicators are loaded onto the SDG Geohive. This work has been formalised through the creation of Ireland's Institute for SDGs (IIS) - an initiative between the CSO, OSi and Department of Environment, Climate and Communications (DECC).</p>
