SCOPE OF THE LAW



This Law regulates relations in the field of formation and operation of the Register,

registration of objects,

compilation and submission to the authorized body of reports of operators, certificates on diffuse sources,

entering data on emissions and transfer of pollutants **to the Register** in relation to objects, as well as diffuse sources located in Ukraine

MAIN GOALS



Establishing the **legal and**organizational basis for the formation
and functioning of the national
register of emissions and transfers of
pollutants



Harmonization of pollution data standards



Facilitation of reporting under international obligations, in particular EMEP, PRTR, etc.



Ensuring openness and availability of data







BASIC PRINCIPLES



Legality



Continuous **improvement of the process** of registration of emissions and transfer of pollutants, as well as the functioning of the Register



Completeness, accuracy, comparability, consistency and reliability of data to be included in operator reports, reports on diffuse sources and entered in the Register



Ensuring public participation in the processes of creating and improving the functioning of the Register



Integration of the Register with other information, information and communication system, databases in the field of environmental protection



Ensuring free **public access** to the Register, reports of operators, reports on diffuse sources, reports of the authorized body







NEXT STEPS



DEVELOPMENT AND ADOPTION OF BY-LAWS

Resolutions of the Cabinet of Ministers of Ukraine

- 1) On approval of the requirements for the report of the authorized body, the procedure for drawing up and publishing such a report;
- 2) On approval of the procedure for maintaining the Register

Orders of the Ministry of Environment

- 1) On the approval of the operator's report form;
- 2) On the approval of the form of the certificate on diffuse sources, the procedure for drawing up and submitting such certificates to the authorized body;
- 3) On the approval of the form of the protocol on the violation by the operator of the requirements of legislation in the field of registration of emissions and transfer of pollutants and waste;
- 4) On the approval of methodological recommendations in the field of registration of emissions and transfer of pollutants and waste.
