1. Adoption of the Agenda

2. Non-Convention signs – road signs for small vehicles

At the last session, the Group reviewed (small vehicle) sign and symbol proposals contained in Informal document No.3/Rev.1 (4 April 2022) and Informal document No. 1 (3 November 2022). After discussion, the proponents with the assistance of FSV were invited to revise the images 1, 4, 5 and 6 as well as “light bus and large bus” and the corresponding definitions. They were invited to submit them in an informal document for the present session. At this session, the Group will discuss Informal document No.1 (6 December 2022).

3. Non-Convention signs – days of week on H panels

At the last session, IROSI was invited to prepare a document on the “days of the week” symbols to be used on additional panels. Informal document No. 2 (6 December 2022) will be discussed.

4. Non-Convention signs – zero and low emission zonal signs

At the last session, the Group invited the Chair together with Denmark to prepare an informal document on zero and low emissions zone signs. Informal document No. 3 (6 December 2022) will be discussed by the Group at the present session.

5. Non-Convention signs – “electric charging and alternative fuels”

At the last session, the Group discussed Informal document No. 1 (11 October 2022) and invited the Chair and the secretariat to prepare a document containing the F, 4 sign complemented by a proposed additional panel (showing alternative fuels (including electricity represented by a plug and cord)) as well as a separate additional panel with “electric vehicle” to complement signs such as C, 18. Informal document No. 4 (6 December 2022) will be discussed at the present session.
