## **ECE Evaluation Workplan for 2024**

### **Note by the Secretariat**

1. The Secretariat presents its Evaluation Workplan for 2024 for approval by the Executive Committee.
2. The Evaluation Workplan for 2024 is presented alongside with the Proposed programme plan for 2024. Subject to the approval of the 2024 Evaluation Workplan by the Executive Committee, evaluation activities will be reflected in paras. 20.17 to 20.19 of the Proposed programme budget for 2024.
3. In line with ECE Evaluation Policy, four internal evaluations are conducted every biennium: three evaluations at the subprogramme level, and one evaluation at the programme level.
4. In 2023, one evaluation at the programme-level will be conducted to review UNECE's role to support the implementation of the 2030 Agenda for Sustainable Development, in the context of the UN development system reform (2017–2023), as contained in Informal Document 2021/36, approved by the Executive Committee at its 119th meeting of 8 July 2021.
5. In 2024, three internal evaluations at the subprogramme-level are proposed for approval by the Executive Committee: Implementation of the Inland Transport Committee Strategy until 2030 (subprogramme 2); Supporting member States in statistics for the Sustainable Development Goals (subprogramme 3); Sustainable resource management: regular budget activities on the United Nations Framework Classification for Resources and the United Nations Resource Management System (subprogramme 5). The respective sectoral Committees were informed accordingly.
6. In line with ECE Evaluation Policy and ECE previous Evaluation Workplans, subprogramme-level evaluations will be conducted by consultants, at the standard rate previously used by ECE for subprogramme-level evaluations.
