### Definition of Counterfeit goods

 Counterfeit goods are goods, including any packaging, label, sticker, brochure, operating instructions, warranty document or similar items which are sold under a brand's name without the brand owner's authorisation. Specifically, this relates to trademark and geographic indication infringement.

# The Danish Ministerial Network against IPR Infringements

Established in 2008 based on a cross-ministerial report on figthing counterfeiting and piracy. 2008 and consists of 12 institutions:

- National Commissioner of Police \*
- Ministry of Culture
- Danish Customs Agency \*\*
- Danish Safety Technology Authority \*
- National Competition and Consumer Authority
- Danish Veterinary and Food Administration \*
- Danish Medicines Agency \*
- State Prosecutor for Serious Economic and International Crime
- Ministry of Foreign Affairs
- Danish Agrifish Agency
- Danish Business Authority
- Danish Patent and Trademark Office (secretariat for the network)

# The Danish Ministerial Network against IPR Infringements

#### **Terms of Reference:**

- Two annual plenary meeting on pre-established dates (March and September)
- The 12 authorities take turns in hosting the meetings (1 day)
- All Network members must participate each time or find a substitute
- All authorities contribute to the dialogue
- No legal basis for the Network in legislation
- No rules on decision-making processes
  - In principle unanimity
  - So far not a problem in practice

### Examples of the Network's results:

- Increased criminal penalties (6 years of imprisonment)
- Information website (<a href="https://ichoosereal.dk">https://ichoosereal.dk</a>)
- Case Law database (Criminal cases on IPR infringements)
- Cooperation on enforcement actions (Operation Opson, Pangea etc.)
- Organizing training seminars for public enforcement authorities
- Continous dialogue with the industry
- Developed standard template for reporting IPR crime
- Contributing to IPR guidelines for police and prosecutors
- Awareness raising campaigns targeted consumers
