# **II.** Annotations

# **1.** Adoption of the agenda

In accordance with the Commission's rules of procedure, the first item to be considered is the adoption of the agenda.

# 2. Transport indicators and monitoring the Sustainable Development Goals

With the implementation period for the 2030 development agenda halfway along, it is an appropriate time to conduct a stocktaking on responses in the transport sector in the Economic Commission for Europe (ECE) region to achieving the Sustainable Development Goals. This agenda item will cover data collection and monitoring activities for each of the Sustainable Development Goal indicators related to transport, as well as looking at transport and the 2030 agenda with a more holistic approach. Member States and other relevant actors will share their own experiences on tracking the transport-related Sustainable Development Goals, as well as any other activities related to monitoring transport through an indicator-based approach (such as monitoring post-COVID transport changes).

The Working Party may wish to make recommendations for additional indicators appropriate for monitoring transport in the ECE region.

The secretariat will provide an update on collecting and disseminating data on road traffic accidents, in the context of monitoring of Sustainable Development Goal indicator 3.6.1 which calls for the halving of road traffic accident fatalities by 2020. There may be presentations from some of the custodian agencies of the transport-related Sustainable Development Goal indicators, as well as other relevant actors.

# 3. Big data and innovation in transport statistics production

This item is an opportunity for member States to share their experiences in using innovative data sources, in particular big data sources, to produce transport statistics. Many member States are at early stages in this process, so knowledge exchange on incomplete projects is particularly welcome.

The secretariat will update member States on progress made by the transport and commuting statistics team of the Mobile Phone Data task team of the United Nations Committee of Experts on Big Data and Data Science for Official Statistics

# 4. Electric vehicle charging statistics

The Working Party will discuss existing definitions for various aspects of electric vehicle charging infrastructure. The Working Party will consider potential international statistical definitions in this space, and further consider if an international statistical collection should be undertaken on a pilot basis.

Further discussions on electric vehicle statistics, such as their impact on electricity grids and quantifying the effect of charging on household energy bills, will be possible.

## 5. Statistical activities of member States

This standing agenda item allows member States to share their current and future activities in the field of transport statistics. Any presentations of current projects and plans for the future are welcome. Delegates are encouraged to discuss their planned interventions with the secretariat beforehand.

# 6. Data collection, methodological development and harmonization of transport statistics

#### (a) Tram and metro statistics

The secretariat will present a brief update on the collection of tram and metro statistics and their value for tracking public transport and as input into modal split calculations.

#### (b) Common questionnaire

The availability of data collected through the web common questionnaire for transport statistics (WebCoQ) will be discussed, in addition to the activities of the three custodian organizations aimed at increasing the response rate and improving data quality over the last twelve months.

## (c) Vehicle statistics and data gaps

Member States will update on various aspects of vehicle statistics, such as ascertaining the locations where passenger and goods vehicles are actually driven (on both a sub-national and international basis), which can feed into the planning of electric charging infrastructure. In addition, the Working Party may discuss quality issues surrounding vehicle registry statistics and how to best fill data gaps.

#### (d) Transport Data Commons

The secretariat will update the Working Party on its role in the forthcoming Transport Data Commons Initiative, which aims to bring together transport and emissions data from many different sources into a single data warehouse, which would allow easier comparisons between data collected by the Working Party and other international organizations, in particular those outside the ECE region.

## 7. Traffic censuses and geospatial statistics

#### (a) 2020 E-Road traffic censuses

The secretariat will provide an update on the data received so far for the 2020 E-Road traffic census. Some member States have indicated that their 2020 census was delayed or significantly restricted due to the COVID-19 pandemic. The secretariat will present draft recommendations for the 2025 UNECE E-Road traffic census, for the Working Party to consider and possibly adopt.

#### (b) 2020 E-Rail traffic censuses

The secretariat will present draft recommendations for the 2025 UNECE E-Rail traffic census, for the Working Party to consider and possibly adopt.

The secretariat will present progress in improving geospatial transport statistics, with particular emphasis on improving rail and inland waterway traffic statistics. Member States and others may update with their own experiences on this topic, as well as related geospatial datasets such as pollution data.

# 8. Dissemination of transport statistics by the United Nations Economic Commission for Europe

Short country interventions on their own dissemination strategies and products are welcome.
