Sustainable tourism is closely linked with transport and mobility and can also play a significant role in fostering good health and well-being. From travelling to and from countries, to moving within a destination, tourists rely on different modes of transport at every stage of their travels. Tourists are increasingly conscious of the effects of their journeys and actions on climate change and sustainability. As such, many tourists are attracted to destinations and service providers that ensure a certain degree of sustainability, including sustainable mobility services. In addition, promoting active mobility - both a healthy and sustainable form of mobility - will benefit travellers' physical and mental health whilst creating more liveable, vibrant and attractive touristic areas and destinations.

Working on sustainable tourism mobility is not only relevant for countries where tourism is a key part of their economy, but also for those countries looking to boost tourism in the long term. New tourist destinations and mobility patterns can burden sustainability efforts, though these countries also have the opportunity to avoid the mistakes of the past and boost tourism in alignment with sustainable development.

Innovative sustainable mobility strategies are key to making sustainable tourism mobility work in practice and in the long term. The development of such strategies requires joint efforts from governments, transport providers, businesses and travellers.

The side event will aim to provide good practice examples of how governments, in cooperation with local and regional administrations and transport providers, can promote sustainable tourism mobility. Further, the event will contribute to the work of the Partnership on Sustainable Tourism Mobility, created under the Transport, Health and Environment Pan-European Programme (THE PEP) at the Fifth High-level Meeting on Transport, Health and Environment, hosted by Austria in May 2021.
