

1. Opening of the meeting and adoption of the agenda

1. The United Nations Economic Commission for Europe (ECE) Steering Committee on Education for Sustainable Development (ESD) is expected to adopt the agenda for its

eighteenth meeting as set out in the present document. The draft agenda was prepared by the secretariat and the Chair of the Committee.¹

2. Outcomes of the Third High-level Meeting of Education and Environment Ministries (Nicosia, 5 October 2022)

- 2. The Third High-level Meeting of Education and Environment Ministries was held on 5 October 2022, in the framework of the Ninth Environment for Europe Ministerial Conference (Nicosia, 5–7 October 2022), with a view to assessing progress during the past phase of its implementation and considering its future implementation.
- 3. The secretariat will brief the Steering Committee on the major outcomes of the Nicosia Ministerial Conference, such as the adoption of the framework for the implementation of the United Nations Economic Commission for Europe Strategy for Education for Sustainable Development from 2021 to 2030 (ECE/NICOSIA.CONF/2022/10) and the Nicosia Ministerial Statement on Education for Sustainable Development (ECE/NICOSIA.CONF/2022/11), and outline activities to be implemented during the next implementation period.

3. Implementation of the United Nations Economic Commission for Europe Strategy for Education for Sustainable Development

(a) Progress in implementing the Strategy: update on the most recent developments (policies, actions, programmes, initiatives) at the national level

Timing: Thursday, 25 May, 11 a.m.-noon

- 4. The Steering Committee will be informed that the fifth mandatory reporting cycle is planned to be launched before the end of 2023 and therefore there will be no informal questionnaire distributed for completion by the countries for the eighteenth meeting.
- 5. To facilitate tracking progress in the implementation of the Strategy, countries will be invited to update the Committee about any recent outstanding activities and initiatives implemented since the seventeenth Steering Committee meeting (Geneva, 30–31 May 2022), in particular with regard to how the implementation of national strategies for ESD contributes to the new developments and challenges for ESD in the region, taking into consideration the four key strands of the Strategy's new implementation framework (2021–2030) quality education and ESD; whole institution approach and ESD; digital education, information and communications technology and ESD; and entrepreneurship, employability, innovation and ESD as well as the cross-cutting issue of the role of youth in ESD. Given the limited time available, countries will have a maximum of 10 minutes each for interventions.

- 15. The document establishes a road map of activities to be undertaken during the remaining three years of the second implementation phase (2021–2025) and aligned with the mid-term review of ESD for 2030 global framework set for 2025 to further the implementation of the Strategy at the national and international levels, in accordance with the mandate articulated by education and environment ministries at the Nicosia High-level Meeting in 2022.
- 16. The present draft was prepared by the secretariat on the basis of the outline of the draft workplan for the implementation of the United Nations Economic Commission for Europe Strategy for Education for Sustainable Development from 2021 to 2025 (ECE/CEP/AC.13/2022/4), elaborated by the Ad Hoc Group on Strategic Planning in consultation with the Chair and the secretariat and endorsed by the seventeenth meeting of the Steering Committee (30–31 May 2022),³ which was, in turn, prepared on the basis of the framework for the future implementation of the United Nations Economic Commission for Europe Strategy for Education for Sustainable Development from 2021 to 2030 (ECE/CEP/AC.13/2022/3), as adopted at the Nicosia High-level Meeting.⁴
- 17. The Steering Committee will be invited to discuss the list of activities and outputs along the four priority strands outlined in the draft workplan (ECE/CEP/AC.13/2022/4, ECE/CEP/AC.13/2023/3) and to propose concrete steps of implementation including the implementing partner(s), place, date/timeline, estimated cost and funding sources.

- 33.
