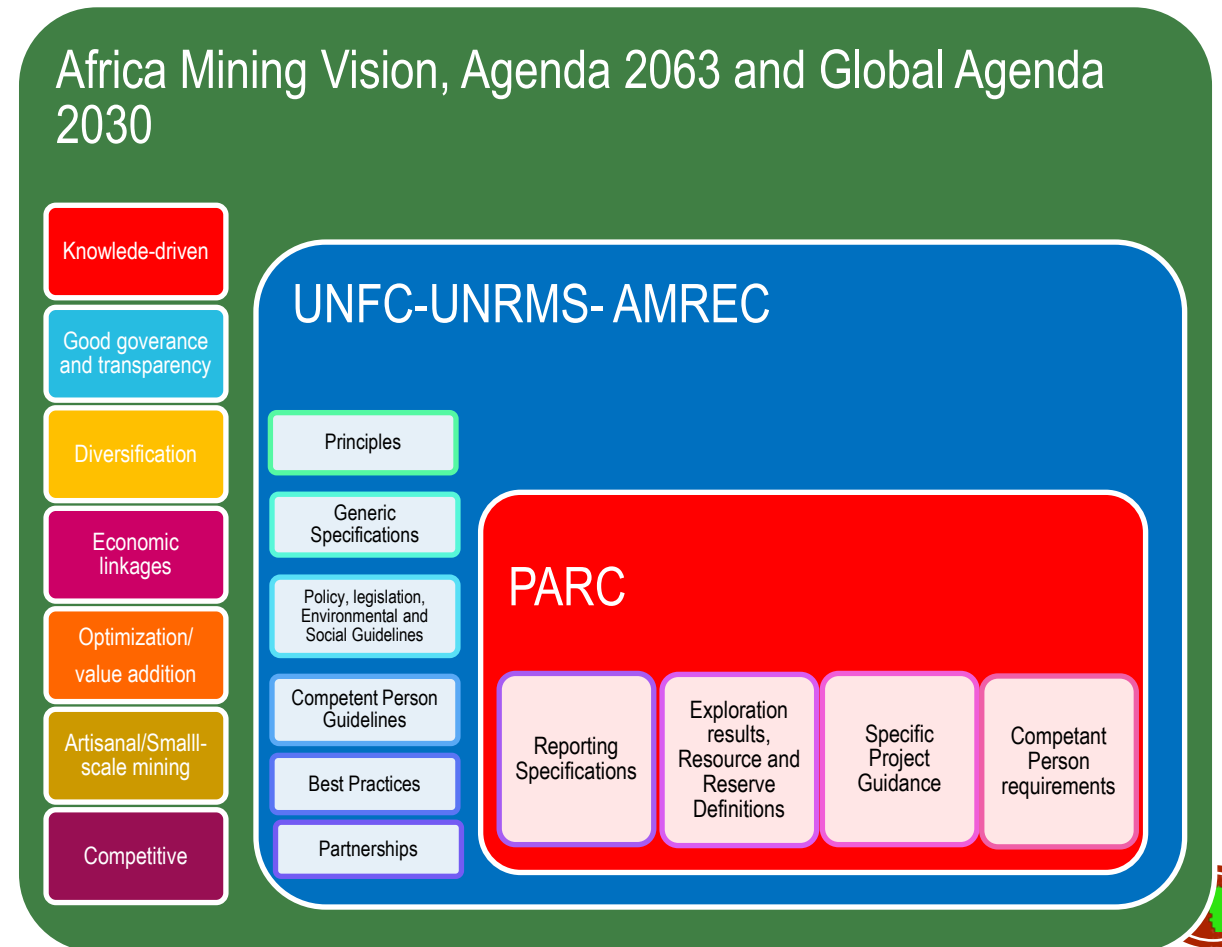


# WHAT IS AMREC-PARC? THE AFRICAN MINERAL AND ENERGY RESOURCES CLASSIFICATION AND MANAGEMENT SYSTEM (AMREC) IS BASED ON UNFC AND UNRMS.



## Key Highlights

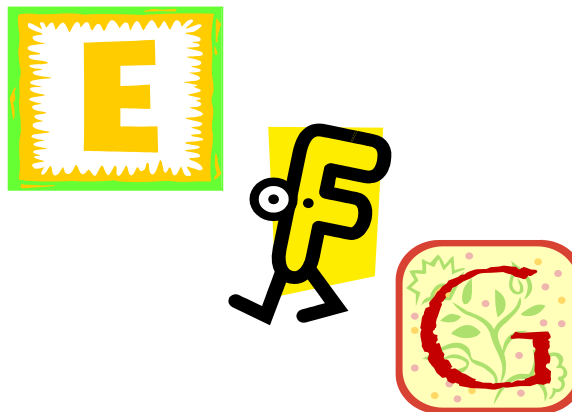
- A comprehensive system for management of Africa’s mineral and energy resources.
- Aligned to Africa Mining Vision (AMV), Agenda 2063 and the Sustainable Development Goals (SDGs)
- Includes the Pan-African Resource and Reporting Code (PARC)
- A single classification and management system for natural resources across Africa based on UNFC and UNRMS.



# UNFC-AMREC CLASSIFICATION FRAMEWORK

- **Based on three fundamental criteria**
  - **Economic and social viability**
  - **Field project status and feasibility**
  - **Geological knowledge**

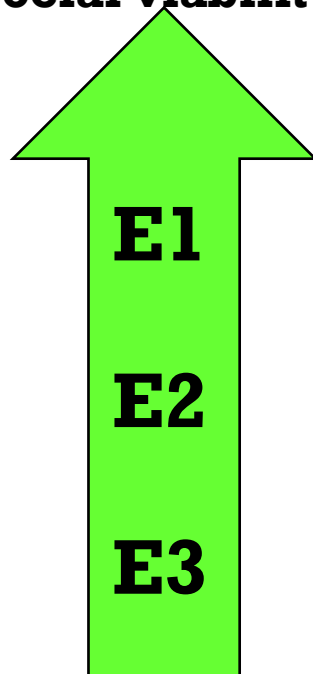

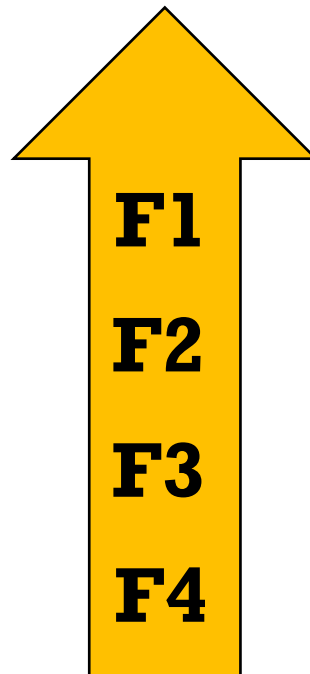

**Numerical coding system based on the three criteria, sub-divided by categories:**

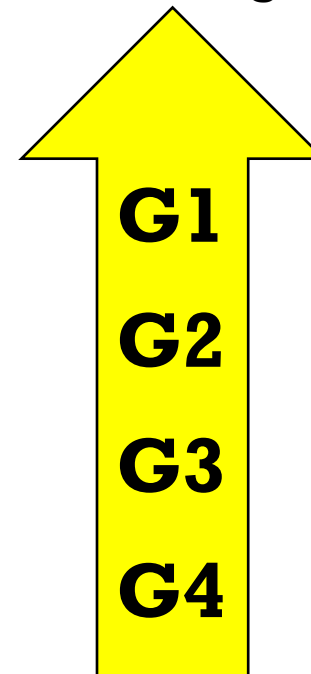

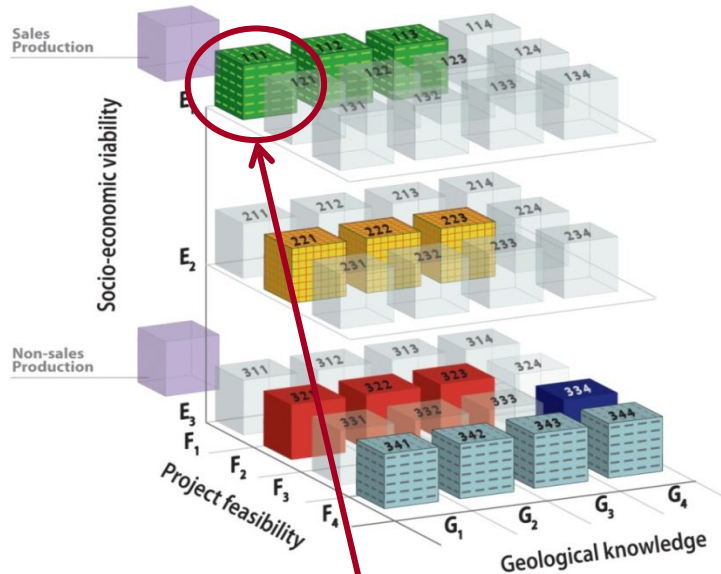

**UNFC Class: 111**

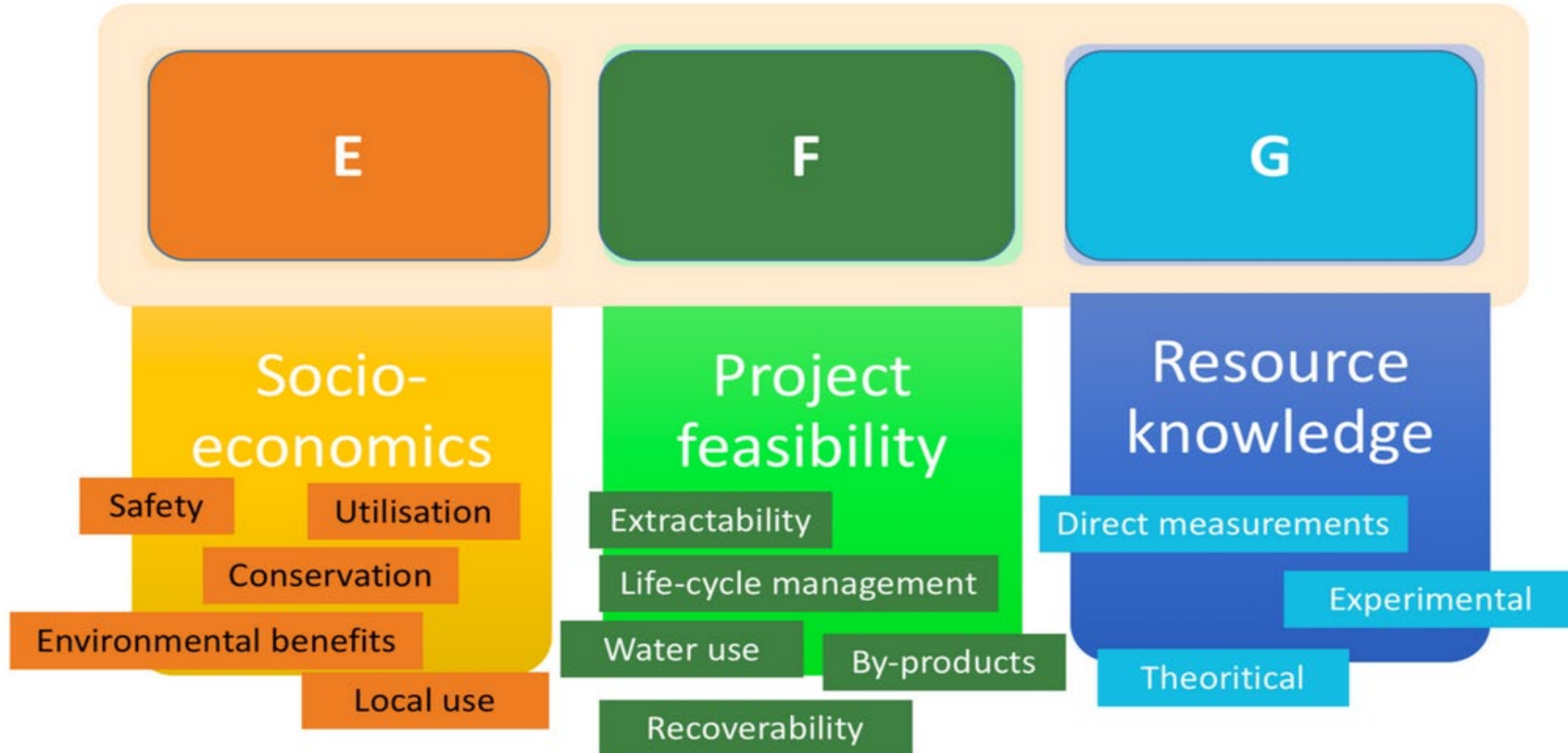
Category	Definition
E1	Production and sale has been confirmed to be economically viable.

Category	Definition
F1	Feasibility of production by a defined development project or mining operation has been confirmed.

Category	Definition
G1	Quantities associated with a known deposit that can be estimated with a high level of confidence.

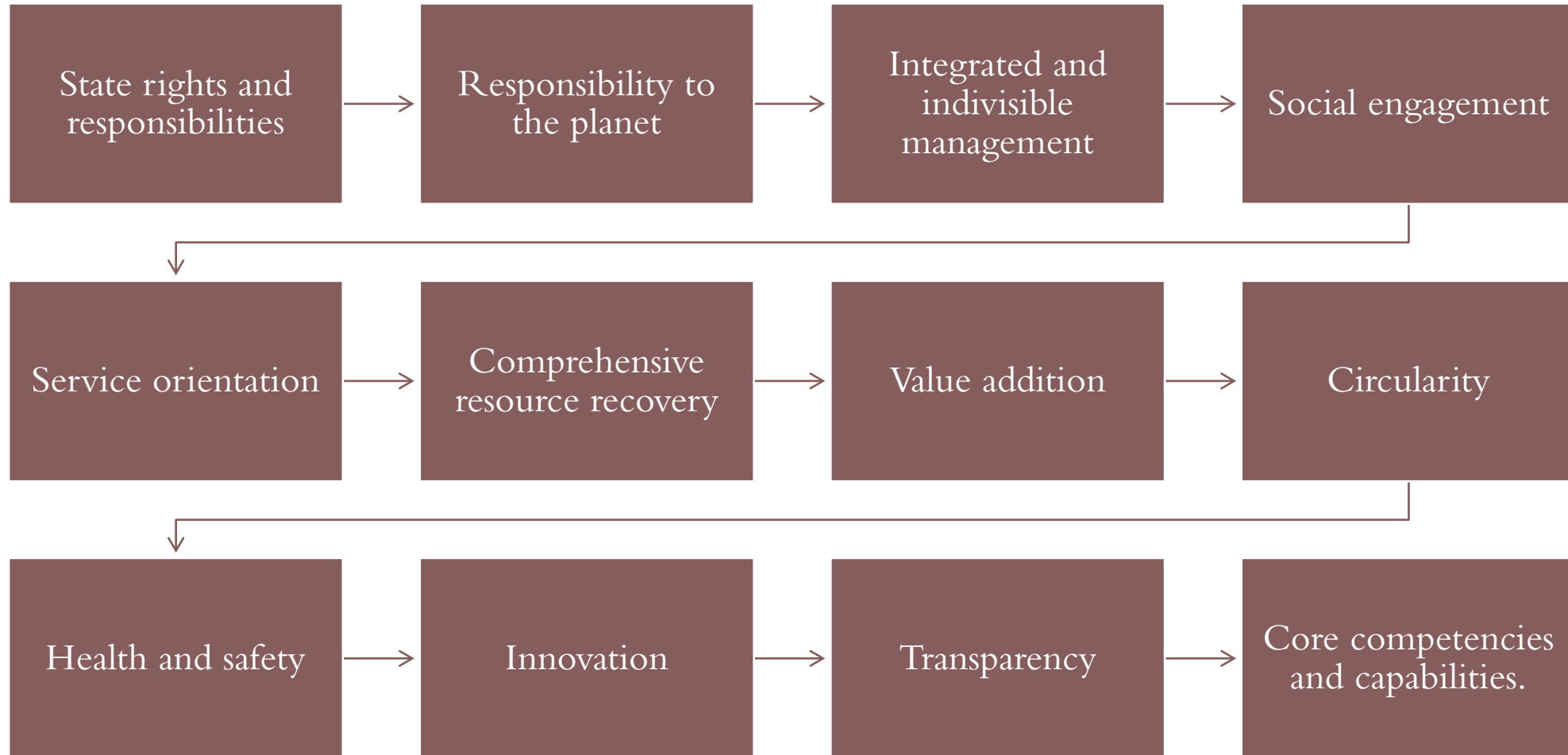

# PAN AFRICAN RESOURCE REPORTING CODE

A gamechanger  
emphasizing  
African values.

- The Pan African Resource Reporting Code is an essential module of AMREC that aims to facilitate transparent financial reporting of mineral projects in Africa
- PARC will be used continent-wide for the industrial financial reporting of the total resource base of Africa, which will help to facilitate access to finance and attract the required capital investments
- PARC addresses the procedures and implementation strategy for recognizing Competent Persons who are experts in mineral resource estimation and reporting.





## AMREC ADOPTION AND RATIFICATION STAGES BY AFRICAN UNION

- ***The AMREC-PARC was adopted for continental use by 3<sup>rd</sup> AU Specialized Technical Committee (STC) of all the 55 member States, Ministers of Trade, Industry and Minerals Resources on 3<sup>rd</sup> September 2021.***
- ***The AMREC-PARC adoption was further consolidated in declarations and approval by Fortieth Ordinary Session of Executive Council that is made up of all Foreign Affairs Ministers of the 55 member States in Africa 3<sup>rd</sup> February, 2022.***
- ***The AMREC-PARC adoption and ratification was finally sealed in the declarations and approval by Fortieth Ordinary Session of Africa Head State of the 55 member States in Africa 5<sup>th</sup> February, 2022. That took place in Addis Ababa, Ethiopia***
- **AMREC-PARC CONTINENTAL IMPLEMENTATION WORKSHOP TOOK PLACE BETWEEN 20-22 APRIL, 2023 AT THE AUDITORIUM OF NAMIBIA GEOLOGICAL SURVEY, WINDHOEK, NAMIBIA**
