Summary

I. Communication and outreach

A. Integrated Communications Strategy

- 1. The Joint United Nations Economic Commission for Europe (ECE)/Food and Agriculture Organization of the United Nations (FAO) Forestry and Timber Section (Joint Section) operates under its secretariat-internal multi-channel, integrated communications strategy to advance the goals and maximize the impact of the Integrated Programme of Work 2022 2025. The communications strategy (available upon demand) supports effective and timely communication with stakeholder groups and leverages the opportunities of digital communications to grow new audiences and expand public engagement with the Joint Section's work.
- 2. Most of the communication work by the Joint Section to promote the work done under the Integrated Programme of Work depends on the availability of extra-budgetary funds. The Joint Section would like to thank Switzerland for generously having supported this work in 2022.

G. Other media and communications outreach

- 12. In line with the Joint Section's internal communications strategy, the dedicated social media accounts established on Twitter (https://twitter.com/UNECEForests), LinkedIn (https://www.linkedin.com/company/unece-forests) and Instagram (https://www.instagram.com/unecefaoforests/) supported the Joint Sections' engagement. These accounts are supported by an ongoing weekly content plan of posts aligned with the objectives of educating and advocating for sustainable forest management, increasing awareness of ECE/FAO initiatives, supporting best practice work, sharing news, data, statistics and other relevant updates and seeking new fundraising opportunities. The Joint Section, in partnership with the Forest Stewardship Council, launched a photo competition entitled "From Woodland to Woodwork" to mark ECE's 75th anniversary from October to December 2022. During the contest, the ECE/FAO community grew by 150%.
- 13. The dedicated social media platforms currently have over 3500 followers between them and have reached an estimated 670 thousand users between March 2022 and March 2023. A dedicated forestry playlist is also available on the ECE YouTube account, with 76 videos and 3,077 views as of March 2023 (https://www.youtube.com/playlist?list=PLC18B48BBE23D5313).
- 14. The Joint Section's INForest data and knowledge platform for forests in the ECE region (https://forest-data.unece.org/) available in Czech, English, French, German, Polish and Russian accumulated 2,895 users and 12,684 views in 2022. In addition, the Forestry module of the ECE Statistical Database (https://w3.unece.org/PXWeb/en/Pivot/) recorded 25,316 downloads in that year.
- 15. The Joint Section also continued to promote the use of sustainable textile materials, launched several social media campaigns and information material.
- 16. The Trees in Cities Challenge, launched in 2019 as a global advocacy initiative to promote urban trees and forestry in cities, continued to grow rapidly in 20221/early 2023. The initiative invites mayors and local governments to make a tree-planting pledge to support

greener, more sustainable and climate resilient cities. As of 15 March 2023, 77 cities had made pledges to plant 12 million trees, and 10.6 million trees have been planted. The initiative is reinforced by a dedicated website (https://treesincities.unece.org/), many social media campaigns and the Informal Network of Experts on Sustainable Urban Forestry. The latter was launched in 2021 as a forum for peer-to-peer learning and sharing best practices. Five meetings on sustainable urban forestry have supported outreach efforts since the last Joint Working Party, including three meetings of the Informal Network. Posts on the Section's social media accounts with a #treesincitieschallenge hashtag had a reach of over 30 thousand views in 2022.

H. Billboard

- 17. The purpose of the Forest Information Billboard is to gather announcements from the forest sector in one place: from forest reporting and new publications to projects and upcoming events.

I. Team of Specialists on Forest Communication (Forest Communicators' Network)

- 19. The annual session of the ECE/FAO Teams of Specialist (ToS) on Forest Communication Networks for 2022 was held in Ljubljana, Slovenia in 6-9 June 2022. The session discussed and exchanged information on regional communication issues including the Forest Europe new communication strategy and social media, new EU Forestry Strategy and the relevance of the European Union Forest Communication Strategy 2011, FAO sustainable wood campaign and how to scale up innovative green value chains, achievements of the ToS team, and the current situation of forest pedagogy in Europe.
- 20. The ECE/FAO Forest Communicators' Network's annual meeting 2023 as well as a workshop will take place in person in Prague on 20–22 June 2023. This meeting will focus on the role of innovative technology in impactful communication as well as a unique focus on urban forestry. The meeting will also consider the latest best practices in forest communication and discuss trends in forestry in Europe.

K. Key points on communication for guidance and discussion

- 22. The Working Party is invited to discuss:
- (a) The possible amplification of the Joint Section's work by actively engaging on its social media channels, and continuing to send inputs to the Forest Information Billboard and other outlets;
- (b) How the Joint Section could increase its outreach with the help of member States, and increase access to more sustainable funding;
- (c) How to Team of Specialists on Forest Communication could be engaged regularly and effectively for communication on the implementation of the Integrated Programme of Work 2022-2025.

II. Capacity-building

A. Forest Reporting

- 23. In the area of forest reporting and to enhance the capacity in member States, the Joint Section worked in several areas:
 - In March 2023 the Joint Section published the study, "Reporting on Forests and Sustainable Forest Management in the Caucasus and Central Asia". Funded via the United Nations Development Account (UNDA-10th tranche) project, "Accountability Systems for Sustainable Forest Management in the Caucasus and Central Asia". The publication presents a set of national criteria and indicators developed with and for the beneficiary countries, as well as provides knowledge on use of this tool. While some of the content is bespoke for the beneficiary countries, most of it is valid for all ECE member States.

- The Joint Section also continued its work on a project aiming at "Strengthening capacity of policy and decisions makers, and forest service specialists to develop national forest information systems in Eastern Europe, Caucasus and Central Asia". Via a dedicated survey, in consultation with national experts, an analysis of common challenges of forest information management in the beneficiary countries has been carried out and a guide on developing a Forest Information System (FIS) is being drafted. Pilot applications in Kyrgyzstan and Uzbekistan have been initiated.
- As a part of the 2025 cycle of the Global and Joint pan-European Data Collection on forests and sustainable forest management, it is foreseen that the work of national correspondents to these processes will be supported by international experts. Further support might be provided through the organization of two capacity-building workshops for countries of the region, in cooperation with FAO and Forest Europe. The implementation of the planned measures depends on the availability of funding.

B. Forest Products

1. Forest products production and trade

24. On 3 April 2023 the Joint Section organized a webinar on the Joint Forest Sector Questionnaire (JFSQ) to present updates to the structure of the JFSQ for 2022 data that were agreed by the Intersecretariat Working Group on Forest Sector Statistics that manages the JFSQ. The webinar also provided an introduction to the JFSQ for new correspondents.

2. Wood energy production and consumption

25. The Joint Section organized three online capacity building modules to train national forestry and energy data experts on the Joint Wood Energy Enquiry. The training was held on 17, 20 and 27 April 2023. The first module provided an overview on the history, context and structure of the Joint Wood Energy Enquiry (JWEE) and invited major actors for the energy statistics to provide an overview on their work related to wood and solid biomass. The first and basic module was recorded and made available on the website of the Joint Section. Modules two and three offered opportunities for peer learning and interaction with the Joint Section in a question-and-answer format.

C. Forest Landscape Restoration

- 26. The Joint Section in cooperation with individual experts finalized a study on the production of forest reproductive material for forest landscape restoration in the Republic of Moldova. The study was developed upon request of the Ministry of Environment of the Republic of Moldova to the ECE.
- 27. The Joint Section completed a Forest Landscape Restoration Knowledge Platform. This Platform will support member States in strengthening their forest landscape restoration efforts and facilitate regional cooperation. The Platform is expected to serve as a sub-regional hub of information on forest landscape restoration relevant to the region, to:
 - Provide a compendium of general information on ecosystem and forest landscape restoration;
 - Disseminate information about forests and forest landscape restoration to international experts, stakeholders, and potential donors;
 - Serve as a comprehensive compilation of resources, including methodologies, training materials, and best practices to facilitate forest landscape restoration.
- 28. The Platform will be made available in English and Russian and is expected to be open for expansion depending on the needs of users and the availability of funds.

D. Urban Forestry

- 29. The Joint Section supported the government of Uzbekistan in the organization of a workshop on "Scaling up Urban Greening and forests in cities" in March 2022, in Tashkent, and held a National Forest Policy Dialogue in September 2022, in Tashkent.
- 30. The workshop "Future-proof green cities make future-proof countries Building urban und peri-urban tree and forest resilience" was jointly organized by ECE, FAO and the United Nations Development Programme (UNDP) Uzbekistan, on 6-8 December 2022, in Budapest, Hungary.
- 31. The Joint Section organized five meetings of the Informal Network of Experts on Sustainable Urban Forestry
 - Urban Forests for Future-Proof Cities, a Regional Forum for Sustainable Development 2022 Round Table (7 April 2022);
 - Collaboration on Benchmarking 2nd Meeting (5 Oct 2022);
 - UNECE Urban Forest Policy Roundtable (16 September 2022);
 - Are all urban trees created equal? Benchmarking for evidence-based urban forest policy and planning (12 Dec 2022);
 - The city of the future is a green city: why we need trees in our cities for the Sustainable Development Goals (SDGs), a Regional Forum for Sustainable Development 2023 side event (30 March 2023).

E. Planned main activities for 2023 and 2024 on Capacity-building

- 32. The Joint Section plans to organize the following activities in the work area on capacity building:
 - Organization of national consultations on development of forest information systems in Kyrgyzstan and Uzbekistan;
 - Organization of a workshop on development of forest information systems in Eastern Europe, the Caucasus and Central Asia;
 - Publication of the Guide for development of forest information systems;
 - Upon availability of funds, co-organization of two capacity building workshops in support to 2025 global and pan-European data collection;
 - Organization of national workshops on development of circular value chains for forest products in the Caucasus and Central Asia;
 - Organization of meetings of the Informal Network of Experts on Sustainable Urban Forestry.

F. Key points on capacity building for guidance and discussion

- 33. The Working Party is invited to:
- (a) Comment on the implemented and planned work on improving capacities in member States;
- (b) Indicate emerging needs and further strengthening of the Joint Section's capacity building for capacity building;
- (c) Advise on additional funding opportunities, including the involvement of member States in the work on capacity building.
