

### Grounded Theory – a qualitative inductive methodology for developing theories





### What is grounded theory (GT)?


A method of generating theory based on patterns found in data (everything is data)

Glaser och Strauss (1967) believes that a produced theory always must be grounded in data:

*"the basic theme in our book is the discovery of theory from data systematically obtained from social reserach"*

# The GT specifies how to map the data collected. Eneroth (1994) writes that:

"This method means that when you are faced with a lot of clarified data, you systematically try to group and regroup them, until you have made as complete a mapping of the phenomenon as possible based on these given data"








#### From induction to deduction
