

My Reflections on Ecosystems and Security

- the way "Ecosystems" is being described, it could also mean an administration and governance of variable geometry for the contribution towards smart city concepts (see The "Mapped Out" Paths to Digitisation, Swiss Think Tank Dimension Cadastre, 2017)
- the term "Ecosystems" might lead to misinterpretations; it has previously also been used for "meta platforms", such as for example for Google or Apple data and services platforms or ecosystems
- the 3 levels of Security (tenure, data, system security) are key to any successful LAS; a key indicator might also be the amount of mortgages given by banks
