Dear Sir/Madam,

On behalf of our AIE Officer Colm Walsh, we grant your request and An Bord Pleanála can create an electronic copy of the file to provide you. We note you have requested access to environmental information in a particular manner.

The information requested is already available to the public in another manner that the Bord deems reasonable and easily accessible in line with section 7(3) of the AIE regulations via our public access service. Our public access team facilitate requests for decided case file documents such as 315288 which you requested, as these are already in the public domain. This team interface with our archival service as such are positioned to provide you the information requested in the most expedient manner. Please note with the public access service, you can avail of access to the case files at your own convenience. As such, I have forwarded your request to my colleagues in public access who will be in touch with regards to the particulars for your request. The public access team will charge an associated fee enabled under section 15(1) of the AIE Regulations for scanning or copying, details of fees are laid out in our public access guide, should you wish to obtain copies of such documents. 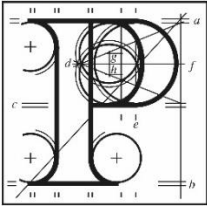
