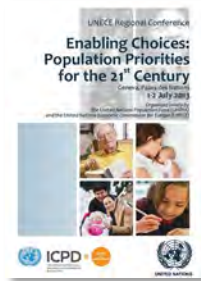

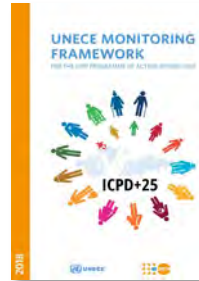

 - Member States, civil society partners, academia, private sector, UN system and other stakeholders

 - Regional technical report on ICPD30 (September)
 - Regional Conference (19-20 October 2023)

Regional technical report

Objectives – highlight trends and policy developments

Method – quantitative analysis of trends based on monitoring framework, desk review of available information and invitation of inputs of policy examples by member States and other stakeholders

Timeline – May–August 2023

Executive summary in 3 official languages ahead of the conference

Full report will be available in September 2023



Road Map - lead up to the regional conference in Europe and Central Asia

- Regional conversations on SRH, Cervical Cancer, Data and Census, Gender sensitive family policies, engaging men and boys in promoting gender equality and health
- Youth consultation on ICPD agenda and SDGs;
- Pre-conference meeting for CSOs, academia and young people

Regional Conference on ICPD30

Population and Development: Ensuring Rights and Choices

Geneva, Palais des Nations, 19-20 October 2023, Salle XVIII

Two Co-chairs

Conference will bring together 200-250 representatives of governments, MPs, local authorities, academia, CSOs, private sector, international and regional organizations.

Interpretation English, French, Russian.

Objectives

- review progress achieved and identify gaps in implementation;
- strengthen linkages for acceleration of ICPD and the 2030 Agenda for Sustainable Development;
- chart pathways for realizing individual and societal potential in new demographic realities.

Thematic sessions

1. Population Dynamics and Sustainable Development
2. Families and sexual and reproductive health over the life course
3. Inequalities, social inclusion and rights

Conference Outcomes

Conference conclusions with recommendations for follow-up over the next implementation period will be presented by the Co-chairs during the closing session conference and will be annexed to Conference Report.

ICPD30 Regional Report and Conference Report will contribute to Global Review at 57th session of Commission of Population and Development in April 2024.
