

III. Guidelines for the transfer of contributions to THE PEP

- 2. The secretariat provides bank information for the transfer of contributions to ECE and WHO/Europe to ensure the effective implementation of the workplan of THE PEP and the adequate participation of experts from countries in Eastern Europe, the Caucasus and Central Asia in its meetings. Contributions should be transmitted to the ECE THE PEP Trust Fund and/or to WHO/Europe.
- 3. For administrative reasons, funds for personnel and information technology infrastructure for THE PEP Clearing House should be made available to the ECE Trust Fund, while support for additional services to be provided by the Clearing House can be made available to either ECE or WHO/Europe. In general, resources made available through the ECE Trust Fund mainly support activities that have a strong transport and environment component. Funds promoting primarily health-related objectives should be directed to WHO/Europe.
