Summary

This report of developments will update the Plenary on the United Nations Centre for Trade Facilitation and Electronic Business (UN/CEFACT) Bureau activities since the twenty-seventh Plenary on 19-20 April 2021. It provides a concise overview of the developments of each programme development area as well as three annexes presenting a list of all UN/CEFACT Bureau decisions since the last Plenary session, a list of all conferences attended which were reported in regular UN/CEFACT Bureau calls, and a list of all projects which were active during this reporting period.

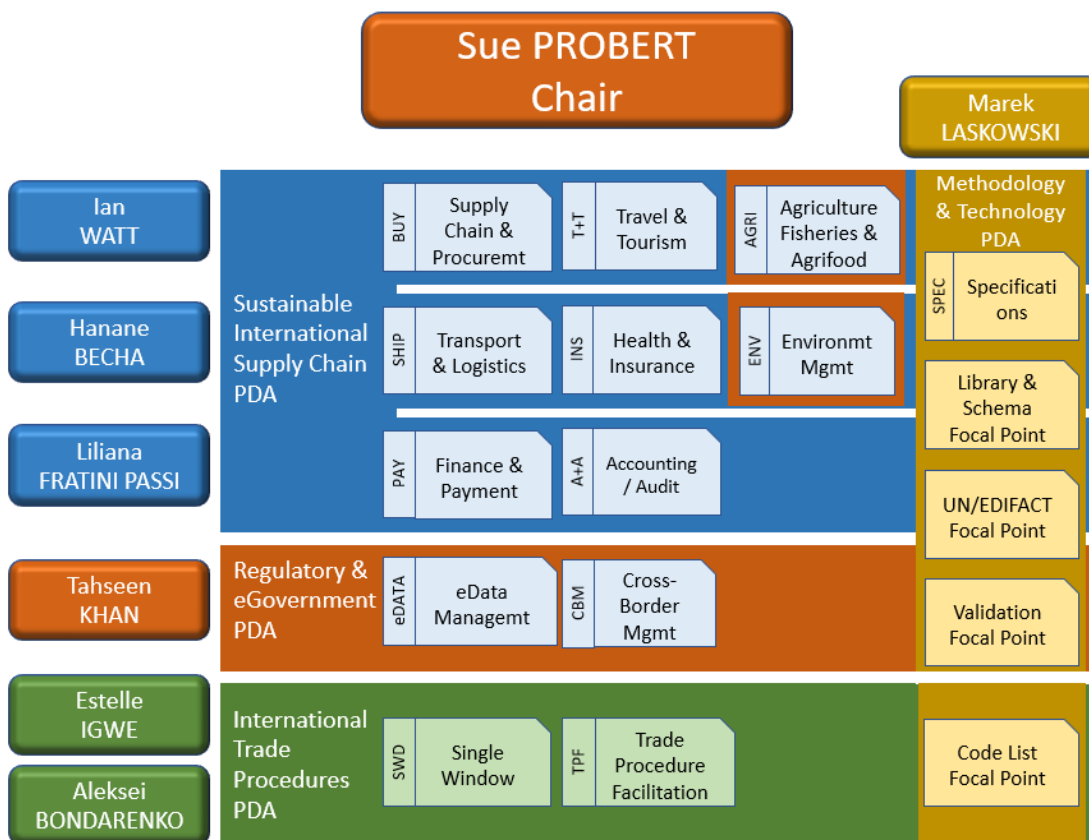
Document ECE/TRADE/C/CEFACT/2022/5 is submitted by the Bureau to the twenty-eighth UN/CEFACT Plenary for information.



I. UN/CEFACT Bureau reporting on the years 2021-2022

1. Since the twenty-seventh Plenary on 19-20 April 2021 until August 2022, the UN/CEFACT Bureau has held eighteen regular Bureau calls during which project development and procedural points were discussed. As per the *Consolidated UN/CEFACT Mandate and Terms of Reference* (ECE/TRADE/C/CEFACT/2017/15) article 49, a list of all Bureau decisions is provided in Annex I. There were 98 Bureau decisions during this period.
2. The structure of the Bureau and the responsibilities of the vice chairs (VC) were updated in November 2021 following the resignation of Mr. Benno Slot on 1 November 2021 by Bureau decision 2111041 per the *Consolidated UN/CEFACT Mandate and Terms of Reference* article 70. (Figure below) Mr. Harm Jan van Burg temporarily took over as acting vice chair during Mr. Slot’s medical leave from 29 March 2021 until 31 October 2021 per Bureau Decision 2103102 per the *Consolidated UN/CEFACT Mandate and Terms of Reference* article 70 following the proposal of the Chair.

3. The domain coordinators and focal points were nominated by the Bureau in July 2020 for a two-year term by Bureau decision 2007020. This decision was made in line with the procedures outlined in the *Terms of Reference for Domains and Domain Coordinators* (ECE/TRADE/C/CEFACT/2016/13) following a call for candidatures

published on the website on 9 June 2020. According to the Bureau decision 2203068, the term of the domain coordinators and focal point leaders was extended until 15 July 2023. The current domain coordinators and focal points are as follows:

4. The Bureau and secretariat strive to keep track of all meetings at which UN/CEFACT is officially represented. There is a conscious effort to ensure that the work is presented in a consistent manner in the interest of the organization. Ninety events were recorded on regular Bureau calls. The full list is available in Annex II.
 5. A full list of all projects that were active between May 2021 and August 2022 and their status is available in Annex III. As per the UN/CEFACT *Open Development Process* (ECE/TRADE/C/CEFACT/2016/17) article 24, all new projects submitted during this period are highlighted in this table.
 6. As of August 2022, there are 1,631 experts registered within UN/CEFACT.

II. International Trade Procedures Programme Development Area

7. Since the last Bureau report, the International Trade Procedures (ITP) Programme Development Area (PDA) completed *Recommendation No.2: ECE Layout Key: Semantic information and codes in international trade data exchange* (ECE/TRADE/C/CEFACT/2022/7), a Report of Trade Procedures Facilitation Domain on Private Sector Participation in National Trade Facilitation Bodies (ECE/TRADE/C/CEFACT/2022/15) and a business requirement specification (BRS) on trade information portals (TIPs).
8. Current active projects of the ITP PDA include the following:

- Digital Product Conformity Certificate Exchange;
- Trade Information Portals;
- Recommendation on Encouraging Private Sector Participation in NTFBs; and
- Single Window Assessment Methodology.

III. International Supply Chain Programme Development Area

9. Since the last Bureau report, the International Supply Chain (ISC) PDA has published a Report of Finance and Payment Domain on Open Finance to Support Trade Facilitation (ECE/TRADE/C/CEFACT/2022/14) and completed and launched an eNegotiation BRS, Supply Chain Management Process (SCMP) BRS, Cross Industry Despatch and Receive Process BRS, Cross Industry Scheduling Process BRS, and a BRS for the Experience Programs Information Exchange Process.
10. Current active projects of the ISC PDA include the following:
 - Accounting and Audit Reference Data Model;
 - Business Standards for Sustainable Tourism;
 - Cross Industry Invoice Light version (CII Light);
 - Cross Industry Supply Chain Track and Trace;

 - Transfer of title compliant to the UNCITRAL *Model Law on Electronic Transferable Records (MLETR)*.

IV. Regulatory/E-Government Programme Development Area

11. Since the last Bureau report, the Regulatory/E-Government (REG) PDA has published a Report of the eDATA Management Domain on the Internet of Things in Trade Facilitation: the Internet of Things in Supply Chains and Government Services (ECE/TRADE/C/CEFACT/2022/11); a Report of the eDATA Management Domain on the Internet of Things in Trade Facilitation: Guide to Internet of Things Technology, Communications and Connectivity (ECE/TRADE/C/CEFACT/2022/12), Report of eDATA Management Domain on Internet of Things Standards for Trade Facilitation (ECE/TRADE/C/CEFACT/2022/13), Report of eDATA Management Domain on Verifiable Credentials for Cross Border Trade (ECE/TRADE/C/CEFACT/2022/16), and prepared a Guide on Code Lists and Identifiers in Garment and Footwear Value Chains (ECE/TRADE/C/CEFACT/2022/10), a Report on Blockchain Pilots in the Garment and Footwear Sector (ECE/TRADE/C/CEFACT/2022/9). The PDA has also published Cross-Border Management Reference Data Model and a BRS for Preferential E-Certificate of Origin.

V. Methodology and Technology Programme Development Area

13. The Methodology and Technology (M+T) PDA has finalized and published all semi-annual releases for the UN/EDIFACT directories (D.21A, D.21B and D.22A), the United Nations Code for Trade and Transport Locations (UN/LOCODE) directories (2021-1, 2021-2 and 2022-1), the Core Component Library (versions D.21A, D.21B and D.22A) as well as the corresponding XML Schema Library (versions D.21A, D.21B and D.22A). The PDA has further updated and published Core Components Business Document Assembly Technical Specification Version 1.1. and XML Naming and Design Rules for CCTS 2.01 Version 2.1.1.
14. Current activities of the PDA include work on the Technical Specification for Application Programming Interfaces (APIs), the development of JSON-LD Web Vocabulary, and Maintenance of Core Components Business Document Assembly (CCBDA) and XML Naming and Design Rules (NDR).
