One of the core objectives of the publication is to inform the audience about the situation of production and consumption of forest products markets and their contribution to accelerate progress towards the achievements of the Sustainable Development Goals (SDGs). The first chapter of the publication on Economic Overview and Policies lends itself to be a good place to include information, data and statistics on the SDGs relevant to the various forest products market sectors. The Joint UNECE/FAO Forestry and Timber Section (the Joint Section) will focus mainly on highlighting the information for SDGs 7 and 12. These solutions could include – but may not be limited to – (partially) automated text generation automatized interactive graphics based on information from the database, and shorter expert assessments by each market segment.</b>	<p>UNECE accepts the recommendation. The Joint Section, in consultation with ECE Programme Management and Support Services Division, will explore possible technical solutions (aligned to available resources) that could assist in the adjustment of the current workflow to the actually available and allocated human resources.</p> <p>To that effect, the Joint Section will consult with the members of the Team of Specialists (ToS) on sustainable forest products, with ECE Programme Management and Support Services Division as well as relevant sections/departments within the UN about possible options and experiences with streamlined publication production workflow, including semi-automated text generation and interactive graphs with a view to facilitate possible automation within existing resources.</p>	FLHD	31 December 2023	<p>In progress</p> <p>The secretariat had initial discussions with experts in member States about organizing a webinar on the issue in order to increase its capacities to automatize text in future editions of the publication.</p> <p>The webinar is expected to be held in Q3 of 2023.</p>

These statements are prepared for the meetings of the Committee on Forests and the Forest Industry. As the structure and main topics of the Country Market Statements are prepared by the Joint Section and requests for the country market statement will be sent in Q3 2023 to member States, the Joint Section will include in the 2023 template a request for relevant information on gender and human rights issues related to the forest market sector. The Joint Section will, in a second step, use the information provided by member States, and add a segment in the economic overview and policies chapter of the Market Review of 2024. The request for the country market statements was sent to member States in June 2023 with a submission deadline of October 2023.
