#### **Background - Review of the Statistics Act**

- Previous statistics act from 1989
- The EEA Agreement (1994)
  - More than 300 EU legal acts on statistics are implemented in Norwegian law
  - the European Statistical Law (223/2009 rev 2015)
  - European Statistics Code of Practice (2005 rev 2011 and 2017)
- The peer review 2014 recommended that the statistics legislation should be reviewed regarding:
  - Independence (role of the Board and the responsibilities of the Director General)
  - Coordination (Statistics Norway's role and the Statistics Council)
  - Definition of official statistics
- Technological changes data collection, sources, dissemination and other producers

#### The Law Committee – mandate

- scrutinise the European legislation and assess if the current statistics act is in line with the European statistical legislation
- assess the division of labour and coordination between Statistics Norway and other public authorities producing statistics or owners of public registers
- · evaluate if common quality criteria should be used in defining «official statistics»
- consider if other public authorities could produce official statistics
- assess if Statistics Norway in a larger extent than today could access confidential information including health data
- consider how personal protection should be respected when more sensitive data are collected, and which limitations should be introduced
- consider if Statistics Norway should be granted more competence (influence) regarding design and content of new registers or changes in existing registers
- assess if Statistics Norway needs further legal authority to access "big data" from public and private sources
- assess if statistical microdata could be utilised by other public authorities for policy planning etc
- evaluate if analysis and research based on statistics should be a task of Statistics Norway regulated by the Statistics Act
- evaluate principles for commissioned work and pricing policy of external assignments
- consider if Statistics Norway may still have a board or a scientific council and which tasks such a body should undertake

- Standing Committee's report 28 May 2019
- Parliamentary treatment 12 June 2019
- Parliamentary treatment 17 June 2019
- Royal assent 21 June 2019

## **New Statistics Act: implementation**

Adopted by Parliament, stepwise entry into force:

0	1.11.2019	Committee	for	official	statistics

• 1.1.2020 Council for Statistics Norway (replaced the Board)

• 1.1.2021 The main part of the Act

Regulations and guidelines

• 1.1.2021 Programme of official statistics







#### The Statistics Act

- Act relating to official statistics and Statistics Norway
- First two chapters on official statistics and three chapters on Statistics Norway
- 23 sections (paragraphs)
- Fully implemented 2021



#### **Purpose of the Statistics Act**

#### Section 1 Purpose

The purpose of the Act is to promote the development, production and dissemination of official statistics with a view to increasing public knowledge, and providing a basis for analysis, research, decision-making, and general discussion in society



### The objectives of Statistics Norway

#### Section 17 Responsibilities of Statistics Norway

- Statistics Norway is the central authority for the development, production and dissemination of official statistics in Norway.
- Statistics Norway shall also conduct research and analysis.
- Statistics Norway may undertake other responsibilities to the extent that these support the activities stipulated in the first and second subsections.



## Some of the main aspects of the Statistics Act

- A national programme for official statistics
- A committee for official statistics
- Strengthened mandate for data collection
- More data sharing
- Clarifying governance of Statistics Norway and the professional independence
- Council for Statistics Norway

- Solid reasons for change
- A clear mandate for review
- Credibility and trustworthiness
- An unambiguous draft proposal
- Thorough processes at all stages and involvement
