UN/CEFACT Bureau report of developments

Summary

This brief report aims to update the Plenary on UN/CEFACT Bureau activities since the twenty-fifth session. It provides a brief overview of developments of each Programme Development Area as well as three annexes presenting a list of all UN/CEFACT Bureau decisions since the last Plenary session, a list of all conferences attended which were reported in regular UN/CEFACT Bureau calls and a list of all projects which were active during this reporting period.

Document ECE/TRADE/C/CEFACT/2020/INF.3 is submitted by the Bureau to the twenty-sixth UN/CEFACT Plenary for information.

- Since the twenty-fifth session of the Plenary, the UN/CEFACT Bureau has held fifteen regular Bureau calls and two face-to-face meetings during which project development and procedural points were discussed. As per the UN/CEFACT Terms of Reference article 49, a list of all Bureau decisions is listed in Annex I. There were 104 Bureau decisions; more than half of these related directly to projects. The number of decisions rose from the previous year partly because the approval of reports of the previous calls is now noted as an official decision.




Figure 1: Bureau structure since May 2018

- 2. The structure of the Bureau and the responsibilities of Vice Chairs has not changed within the past year and Bureau decision 1805001 establishing these responsibilities. (Figure 1)

- 3. The term of office of the Domain Coordinators and Focal Points came to an end in June 2019. The Bureau decided (decision number 1905002) to prolong all Domain Coordinators and Focal Points through to 2020 in order to allow the next nominations to correspond with the elections of Vice Chairs. All Domain Coordinators and Focal Points accepted to continue for a subsequent year.
- 4. The Bureau and Secretariat try to record all meetings at which UN/CEFACT is officially represented. There is a conscious effort to ensure that the work is presented in a consistent manner, in the interest of the organization. 86 such events were recorded on a Regular Bureau call; about half of these were reports from the Secretariat on their efforts to represent UN/CEFACT at conferences. Two of these meetings were attended by UN/CEFACT experts Domain Coordinator who presented the work of UN/CEFACT at a meeting. The full list is available in Annex II.

- 5. A full list of all projects and their status is available in Annex III. As per the UN/CEFACT Open Development Process article 24, all new projects submitted during this period are highlighted in this table.
- 6. As of March 2020, there are 1280 experts registered within UN/CEFACT. The top five delegations in size are the United States of America, the United Kingdom, Italy, China and France. The full list of distribution is provided in the table of Annex IV.

A. International Trade Procedures Programme Development Area

- Since the twenty-fifth session, the International Trade Procedures PDA (ITP-PDA) completed two revisions of existing recommendations: revision of Recommendation No. 33 on Implementation of Single Window (ECE/TRADE/C/CEFACT/2020/7), revision Recommendation No. 5 on the Abbreviations of INCOTERMS (ECE/TRADE/C/CEFACT/2010/10). Two White Papers have also been completed on **MSMEs** in International Integrated Services for (ECE/TRADE/C/CEFACT/2020/11) and on Core Principle of the Operation of Systematically Important Single Window (ECE/TRADE/C/CEFACT/2020/12); the latter is planned to pursue as a project for a recommendation.
- 8. Current active projects of the ITP-PDA include the project on Cross Border Management of Humanitarian Relief which is progressing its status is available in document ECE/TRADE/C/CEFACT/2020/9 and a new project on Trade Information Portals in support of the World Trade Organization Trade Facilitation Agreement Article 1 which was recently launched. The enhancement of UN/CEFACT's Single Window case study repository also continues.
- 9. Potential future work which has been discussed includes guidance on "Smart Corridors", a revision of Recommendation 18 on Facilitation Measures Related to International Trade Procedures and a revision of Recommendation 31 on Electronic Commerce Agreements. The notion of a Single Window Ecosystem may also be put forward in the coming period.

B. International Supply Chain Programme Development Area

- 10. Since the twenty-fifth session, the International Supply Chain PDA (ISC-PDA) completed the revision of Recommendation 16 on UN/LOCODE as well as a number of business standards such as the Buy-Ship-Pay Reference Data Model which provides the framework for nearly all electronic business exchanges in international trade. Business Standards were also completed for Smart Containers, Cross-Border Delivery and Purchase Order Financing. Data Pipeline has also been completed, but too late to report in the Agenda of the twenty-fifth session. Executive Guides were also prepared on Smart Containers (ECE/TRADE/C/CEFACT/2020/15) and on Data Pipeline (ECE/TRADE/C/CEFACT/2020/14).
- 11. Current active projects of the ISC-PDA include:
 - a. Accounting and Audit Reference Data Model
 - b. Application Programming Interface (API) Town Plan
 - Cross Industry Invoice Implementation Repository
 - d. Cross Industry Supply Chain Track and Trace
 - e. IMO eFAL mapping

- Reference Data Model to API
- g. Reimbursement of Healthcare Claims
- h. Transfer of title compliant to the UNCITRAL Model Law on Electronic Transferable Records
- 12. Potential future work may include alignment of data requirements between the tender and procurement process as well as studying the application of new technologies (blockchain, Internet of Things, APIs) on deliverables within this PDA.

C. Regulatory Programme Development Area

- 13. Since the twenty-fifth session, the Regulatory PDA has completed a second version of the Blockchain White Paper work (ECE/TRADE/C/CEFACT/2019/9/Rev.1).
- 14. Following up on the above Blockchain White Paper, there are two other blockchain White Paper projects currently being developed: Cross border Inter-ledger exchange for Preferential CoO using Blockchain and UNECE Chain Project. Similar work is being carried out on Internet of Things for Trade Facilitation and Digital Identity for Trade Facilitation. Work also continues on the Waste Management / Waste Analysis project, building upon the work of the Transboundary Movement of Waste supporting the Basel Convention. An Executive Guide on the latter is presented to the twenty-fifth session (ECE/TRADE/C/CEFACT/2020/13). Work also progresses on the Cross-Border Management Reference Data Model.
- 15. There is discussion of perhaps developing guidance on Artificial Intelligence, Data Retention or Time Stamping.

D. Sectoral Programme Development Area

16. Current active projects of the Sectoral PDA include within the Agriculture Domain the eQuality Certificate Implementation Guide, and an eCert Guide to assist with the implementation of the eCert standard for SPS certificates. Work will continue on the Sustainable Textile and Leather Traceability and Transparency project in collaboration with the International Trade Centre, International Labor Organization and the European Union. The Travel and Tourism Domain progresses its work on sustainable tourism and experience programs.

E. Methodology and Technology Programme Development Area

- 17. The Methodology and Technology (M&T) PDA have finalized and published all semiannual releases for the UN/EDIFACT Directories (D.19A and D.19B), the UN/LOCODE Directories (2019-1 and 2019-2), the Core Component Library (versions D.19A and D.19B) as well as the corresponding XML schemas (versions D.19A and D.19B). Work on all of the first versions for 2020 have been either completed or are near completion. Updates to the code lists in Recommendation 20 on Codes for Units of Measure Used in International Trade and Recommendation 21 on Codes for Passengers, Types of Cargo, Packages and Packaging Materials have also been published.
- 18. Work is currently underway on a Message Construction Guideline and nearly completed for the joint project with Oasis on the Header/Envelope Document Exchange project.
- 19. Technical specifications for Application Programming Interface will likely be developed over the next period.
