Discussed at the TFEIP annual meeting

- Could the impact of approved adjustments be taken into account when reporting projections?

TFEIP Questionnaire

- Questionnaire circulated to the emissions inventory community on the future of reporting under the Convention

- Briefly, some key take-away messages for consideration...

5. Reflections on the future of EI reporting



Improving current reporting is considered more important than adding to the existing reporting

- e.g. Gridded emissions, HM & POPs...

Scope of reporting

- There is no strong request to remove pollutants
- ... but that does not preclude adding e.g. CH₄, or the long-term aim of including ultrafine PM.

Centralizing compilation for some sources is an option that should be explored

- e.g. Shipping, fires...
