Dear Mr. Power.

The EPA acknowledges your commencement notice, submitted on the 08/01/2019, as required under Condition 2.4 of Permit S0031-01 and your request to commence works on the 15th January 2019. Condition 2.4 of the Permit requires that the permit holder gives fourteen calendar days notice prior to the commencement of dumping activities or as otherwise agreed by the Agency.

I acknowledge that you propose to commence the works on the 15th and complete them before the 1st February 2019 as per Schedule A.3 'Closed Period' of the Permit. I also note that as per Condition 4.4 of the Permit that a pre dredge survey is to be undertaken.

The EPA requests, as per the Permit, that the following are in place/undertaken prior to the commencement of the dredging works;

1. A Public Awareness and Communications Programme is established, as per Condition 2.7.1 where members of the public can access information relating to the campaign;
2. As per Condition 2.7.2, that interested parties such as Coastwatch are given advance notice of the campaign;
3. That the permit holder contacts all the consultees listed in Conditions 3.6 and 3.8 prior to the commencement of dumping activities;
4. That the pre bathymetry survey is submitted as soon as possible following the completion of the survey.

The permit holder is required to note, as per Condition 4.5, that a sediment particle tracking study or a sediment dispersion model is to be undertaken. The permit holder is also reminded that they are required to register with the Office of Environmental Enforcement, on www.edenireland.ie. For assistance with this visit the EDEN portal 'Help' section for guidance or email eden@epa.ie.

As per Condition 2.4, the EPA agrees within your request to commence dredging works on the 15th January 2019 with a completion date prior to the 1st February 2019.

You are reminded that you must comply with all conditions of your permit and that this agreement does not negate any responsibility on the permit holder.
