**Communication to the Aarhus Convention Compliance Committee concerning compliance by Ireland with the provisions of the Convention on access to information on the environment by Right to Know CLG (ACCC/C/2016/141)**

Dear Ms Kennedy

We understand that the Irish authorities are due to give an update to the Compliance Committee on progress towards implementing the recommendations flowing from the Compliance Committee's findings in case C/141 that Ireland had:

- (a) Failed to put in place measures to ensure the OCEI and courts decide appeals regarding environmental information requests in a timely manner and therefore failed to comply with Article 9(4); and
- (b) Further failed to comply with Article 9(4) by maintaining a system whereby courts may rule that information requests fall within the scope of the AIE Regulations without issuing any directions for their adequate and effective resolution thereafter.

In light of the above, our client wishes to provide the following information which shows that the problems giving rise to its communication still persist in the Irish system. We ask you to confirm that this letter will be included with the next update provided to the Compliance Committee.

**Delays in the OCEI**

The OCEI has supplied R2K with the latest information on its pending cases which shows that there are currently 364 pending appeals in the OCEI. The median time during which these appeals are pending (as of 23 August 2023) is 271 days, the average is 328 days. 46% of appeals are pending for more than a year with 11% pending for more than two years. We set out in Annex 1 a frequency plot illustrating the situation and in Annex 2 the complete list of cases.

**Delays in the Courts**

We would draw your attention to the recent decision of the High Court in *Bord na Móna plc v Commissioner for Environmental Information and Right to Know CLG* ([2023] IEHC 57). This decision

was made on 7 February 2023. The Court upheld a decision of the OCEI that a request was within the scope of the AIE Regulations. However no directions were given following the Court's ruling with the result that no action was taken by either the public authority or the OCEI following the judgment.

Right to Know made enquiries on 1 August 2023 with the OCEI and essentially asked it to enforce its decision through further litigation but so far no substantive response has been received.

Right to Know would also like to draw your attention to a decision of the Court of Appeal in *Right to Know v An Taoiseach* delivered on 24 March 2023 ([2023] IECA 68). This decision illustrates the ongoing issue with court delays. The appeal was filed on 2 November 2020, the hearing took place on 24 June 2021 yet the judgment was only delivered on 24 March 2023, almost two years later.

### **Delay in actioning review of AIE Regulations**

As you know there was a public consultation on the review of the European Communities (Access to Information on the Environment) Regulations 2007 to 2018 as part of Ireland's action plan to implement the Compliance Committee's recommendations. This consultation closed on 16 April 2021<sup>1</sup>, more than two years ago. Since then, there has been no apparent progress on this review, and as far as Right to Know is aware, no timetable has been provided indicating how it will progress.

It is regrettable that an action plan aimed at eliminating delay from the handling of requests for access to environmental information is itself seriously delayed for reasons which are not apparent.

In any event, while a review of the AIE Regulations is needed and to be welcomed, it remains Right to Know's position that the findings and recommendations of the Compliance Committee can be addressed (at least partially) through non-legislative means, for example through appropriate organizational arrangements in the OCEI and/or through a practice direction of the Courts.

Given that legislative reform appears to present a very serious bottleneck for Ireland's action plan, we again urge Ireland to examine all options to address the Compliance Committee's findings and recommendations to bring Ireland into compliance with the Convention as quickly as possible.

### **Conclusion**

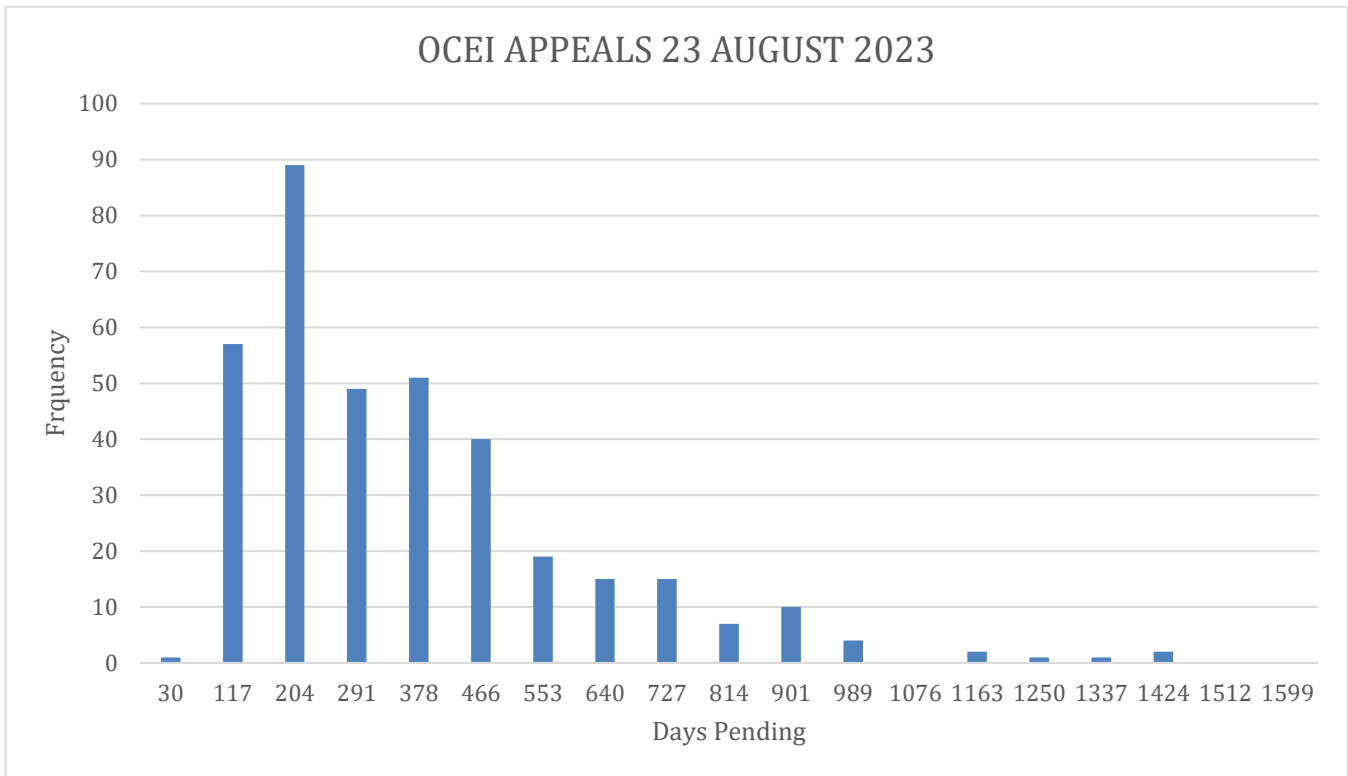
