Information paper No. 9 27 October 2023

Countries eligible for financial support to participate in meetings and events

Note by the secretariat in consultation with the CEP Bureau

1. The Committee on Environmental Policy (CEP) at its nineteenth session (22–25 October 2013) "...took note of the assessment of criteria for providing financial support for participation in meetings and events (ECE/CEP/2013/20), and approved the recommendations contained therein (see paras. 20 and 21)". Paragraph 21 stipulates in particular that "(a) ... The CEP shall take decision at each regular session on either amending the present criteria, or extending them for another period; (b) The draft of a relevant decision of the CEP shall be based on the input from the secretariat, in consultation with the Bureau and its Chair, to be prepared and circulated beforehand ...".

2. According to the mandate referred to in a para 1 above, the Committee at its twentyseventh session (Geneva, 3-5 November 2021) approved the revised criteria for providing financial support for participation in meetings and events, as presented in information paper No. 8, and requested the Bureau, with support from the secretariat, to periodically verify the availability of data for 2021 and, if available for all countries with economies in transition, to prepare revised criteria for financial support for subsequent approval by the Committee.

3. The secretariat continued to monitor data availability. After assessing the situation in mid-October 2023, the secretariat has found that the data series available from different sources exhibit some differences which may affect the integrity of the approach. Namely:

- (a) The Statistical Database of the UNECE (the primary source of data for the CEP decisions) provides the recent 2022 data for some but not all countries¹. Moreover, data for three countries was even older than 2021. The resulting table of countries that fall within the thresholds of eligibility is attached below as Annex 1.
- (b) The United Nations Statistics Division database UNdata (the additional source of data for the CEP decisions) data was even older than that of the UNECE database, so this source was not used.
- (c) For comparison, the World Bank DataBank was also accessed. It had the most recent data of the three sources. Annex 2 combines the UNECE Statistical Database data that was available for 2022, updated with the 2022 data from World Bank DataBank for countries for which the UNECE data was older.

- 4. The criteria contain lower and upper thresholds². The thresholds are the same as adopted by the previous session of the CEP:
 - (a) The lower threshold (for full financial support) is set to 4,500 in current US\$ of the gross domestic product (GDP) per capita.
 - (b) The upper threshold (for full financial support) is set to 5,500 in current US\$ of GDP per capita.
- 5. Other approaches may be applied under projects where donors are earmarking their contributions with particular conditions.

6. In view of various factors that might limit the uniformity of approach for both Annex 1 and Annex 2 tables, the secretariat prepared the present document for the consideration of the CEP Bureau at its meeting of October 31, with the understanding that the Bureau might wish to have comprehensive information before issuing its recommendation to the CEP.

Countries eligible for financial support to participate in meetings and events

1. For the purposes of this paper, "partial financial support" includes Daily Subsistence Allowance (DSA) only; and "full financial support" includes DSA and travel expenses.

2. The lower threshold for financial support equals US\$ 4,500. Representatives of the member States with annual GDP per capita below the lower threshold are entitled to full^a financial support to participate in meetings and events to which the CEP decision applies. Other approaches may be applied under projects with donor contributions on certain conditions.

3. The upper threshold for financial support equals US\$ 5,500. Representatives of the member States with annual GDP per capita between the lower and upper thresholds are entitled to partial^b financial support to participate in meetings and events to which the CEP decision applies.

Countries eligible for financial support to participate in meetings and events

1. For the purposes of this paper, "partial financial support" includes Daily Subsistence Allowance (DSA) only; and "full financial support" includes DSA and travel expenses.

2. The lower threshold for financial support equals US\$ 4,500. Representatives of the member States with annual GDP per capita below the lower threshold are entitled to full^h financial support to participate in meetings and events to which the CEP decision applies. Other approaches may be applied under projects with donor contributions on certain conditions.

3. The upper threshold for financial support equals US\$ 5,500. Representatives of the member States with annual GDP per capita between the lower and upper thresholds are entitled to partialⁱ financial support to participate in meetings and events to which the CEP decision applies.
