The secretariat will report on recent developments in the Steering Committee on Trade Capacity and Standards and the United Nations Economic Commission for Europe (ECE) and other activities within ECE of relevance to the Working Party.

In 2022, the United Nations Office of Internal Oversight Services (OIOS) evaluated the relevance, effectiveness, coherence, sustainability, and integration of cross-cutting issues in Subprogramme 4: Economic Cooperation and Integration, and Subprogramme 6: Trade of the United Nations Economic Cooperation for Europe for the period 2018–2021. The evaluation was part of the UN secretariat's regular program periodically evaluating selected aspects of its operations. Delegates will be briefed on the key findings and recommendations of the evaluation as they pertain to Subprogramme 6, the associated management response, and plans on how to implement relevant recommendations.

The chair of WP.6 will present a report (ECE/CTCS/WP.6/2023/INF.1) on activities during this past period as well as strategic directions for the months to come. This document is presented to the Working Party for information.

The Advisory Group on Market Surveillance (MARS) was established in 2003 to be a forum for discussion about market surveillance, to increase transparency and visibility of the chain of control and to promote coherent best practices. The *Report* of this group (ECE/CTCS/WP.6/2023/3) is presented to the Working Party for an endorsement decision.

The *Recommendation M on the Use of Market Surveillance as a Complementary Means to Protect Consumers and Users against Counterfeit Goods* was approved and published in 2007. It makes the case to involve market surveillance agencies in the control of intellectual property rights. On 21 February 2023, MARS organized a conference to take stock of the implementation of *Recommendation M* and assess whether a revision of this recommendation could be useful. This was announced at the thirty-second session of WP.6 (see ECE/CTCS/WP.6/2022/2, paragraph 16). The *Report* of this meeting (ECE/CTCS/WP.6/2023/4) is presented to the Working Party for information.

Metrology is a cornerstone to international standardization and the quality infrastructure in general, which contributes to the facilitation of trade. *Recommendation K* was first approved and published in 1988 and then revised in 2008. The current, third revised version aligns to current best practices and updated international standards on the topic. The revised *Recommendation K* (ECE/CTCS/WP.6/2023/5) is presented to the Working Party for an endorsement decision.

The Ad Hoc Team of Specialists on Standardization and Regulatory Techniques (START) was established in 1999 with an aim to promote international regulatory cooperation on product technical regulations. These regulations define safety and health requirements which may be unique to the needs and circumstances of each country which can result in higher compliance costs when approaching multiple markets. Several initiatives have been launched to support the ECE *Recommendation L on an International Model for Transnational Regulatory Cooperation Based on Good Regulatory Practice* with common regulatory arrangements (CRA) for telecom, cybersecurity, earth-moving machinery, equipment for explosive environment and pipeline safety. The *Report* of this group is presented to the Working Party for an endorsement decision.

Education on standardization has been a focus of WP.6 and its predecessor since the publication of the ECE *Recommendation I on Education on Standards-Related Issues* in 1970 and reenforced with an updated recommendation in 2012 and the subsequent development of a 16-module model programme on standardization. The *Report* of this initiative is presented to the Working Party for an endorsement decision.

The Gender-Responsive Standardization Initiative was launched in 2016 and was approved as a Team of Specialists on Gender-Responsive Standards (ToS-GRS) in September 2022. The ToS-GRS aims to help support the implementation of the sustainable development goal “Achieve gender equality and empower all women and girls” (SDG 5) through gender-responsive standards. The *Report* of this group is presented to the Working Party for an endorsement decision.

The project on gender and salutation code lists was presented to the twenty-second annual session (see ECE/CTCS/WP.6/2022/2, paragraph 66). The code list document (ECE/CTCS/WP.6/2023/11) is intended to be the base for code lists which could eventually be taken up by UN/EDIFACT, enabling all future messages referencing these code lists to be

gender inclusive. The code lists are created in order to be able to evolve in the future. This code list document is presented to the Working Party for an endorsement decision.

Building awareness and disseminating the work on gender-responsive standards is a core goal of the ToS-GRS. The short publication *Why Gender-Responsive Standards are Better for Everyone* (ECE/TRADE/474) was developed in close collaboration with the members of the ToS-GRS and targets a broad audience which doesn't necessarily have much information on the topic yet. This publication is presented to the Working Party for information.

9. Panel discussion: How to address continuous compliance – Conformity assessment, legal metrology and market surveillance tools for the changing dynamic of digital goods

This agenda item will respond to the decision taken at the 2023 Commission session on “digital and green transformations for sustainable development in the ECE region” (E/ECE/1504).

The panel discussion will explore the challenges of continued compliance of products with embedded digital technologies such as artificial intelligence throughout their life cycles. It will demonstrate the important role that market surveillance, conformity assessment and legal metrology can play in providing traceability, auditability and verification. The panel will delve into the technical aspects of quality infrastructure and targets regulators, private sector companies and the quality infrastructure community in general.

A project on the regulatory compliance of products with embedded artificial intelligence or other digital technologies was launched in early 2023 and has resulted in the development of a document (ECE/CTCS/WP.6/2023/9). This work has been completed as an all-of-WP.6 project involving experts from all subgroups of WP.6 and includes a series of recommendations that governments should consider concerning the regulatory compliance of products with artificial intelligence or other digital technologies. This document is presented to the Working Party for an endorsement decision.

The project team plans to continue its development with guidelines to assist governments in their application of this document. The project team also proposes to develop a high-level policy document which may be a common regulatory arrangement (based on

Recommendation L), a recommendation, a declaration or a convention. The secretariat prepared a background document (ECE/CTCS/WP.6/2023/INF.2) that outlines the details of each of these potential outputs. Working Party members will be asked to provide input on the possible high-level policy document follow-up.

Working Party members and attendees of the panel will have an opportunity to clarify questions and provide comments.
