Action Plan for Implementation of Strategic Framework for Preparing for an Ageing Society 2023-2025

- Resolution of the Government of the Czech Republic No. 786 - 13 September 2021 approved the Strategic Framework for Preparing for an Ageing Society 2021-2025.
- Instructed the Minister of Labour and Social Affairs to submit an Action Plan to the Government
- Specific measures of the Strategic Framework
- Proposal for monitoring and evaluation



The Action Plan is based on the principles of:

- Sustainable development of society
- Intergenerational cohesion
- Emphasis on cooperation of all actors
- An active approach to life and participation in society

Ten points to prepare for an ageing population

1. Fair pensions
2. More accessible and quality social and health services
3. More accessible and barrier-free housing for the elderly
4. Support for the sandwich generation and informal family carers
5. Preparing for an ageing society
6. Family support and interpersonal relations
7. Safe living for the elderly, combating violence and increasing consumer protection
8. Lifelong learning, the labour market and active ageing
9. Barrier-free public space
10. Awareness-raising and media coverage of ageing

The Structure of the Action Plan

Global objectives

1. State cooperation with all actors as a basis for resilient Society
2. An active personal approach to ageing
3. Ageing with dignity and quality of life

- III. Promote employment and adaptability to the labour market
- IV. Promote a secure life for older people
- V. Promote dignified security in old age

9. Barrier-free public space	IV. Promote a secure life for older people	Promote an environment more conducive to all age groups and build barrier-free public spaces
10. Awareness-raising and media coverage of ageing	I. Ensure institutional support for preparing for ageing	Implement awareness raising and educational activities and campaigns for the public/actors

Cooperation of the state and all other relevant actors

- Citizen → Taking responsibility for your own life from a young age
- Family → An important value for most of society
- Associations → Social contacts, healthy and active ageing
- State, Ministries → Creates an environment
- Trade unions → Working conditions that are friendly to all ages
- Local government → Regions, municipalities create an environment for quality and autonomous life
- Employers → Company culture, age management
- NGOs → Healthy and active ageing

Cooperation of the state and all other relevant actors

- Social service providers → Help and support in natural environment
- Academia, all levels of education → Outreach, education
- Media → Awareness of the lifelong ageing process
- Ombudsman → Disadvantages in the labour market, protection against discrimination, abuse, exploitation
- Czech Trade Inspection Authority → Consumer protection
- Health insurance companies → Strengthening healthy lifestyles
- Labour Office → Support for employment of people 50+
- Police, courts, prison service, municipal police → Safety

1. 1. 1. Ensure the sustainability of institutional support for the senior and ageing theme at central level

- Establishment of a focal point on ageing in the departments (ministries) so as to create a basic model for the coordination of ageing policy.
- The permanent Working Group on Seniors and Ageing (of the Government Council for the Elderly)
- Age mainstreaming – all departments are involved
