

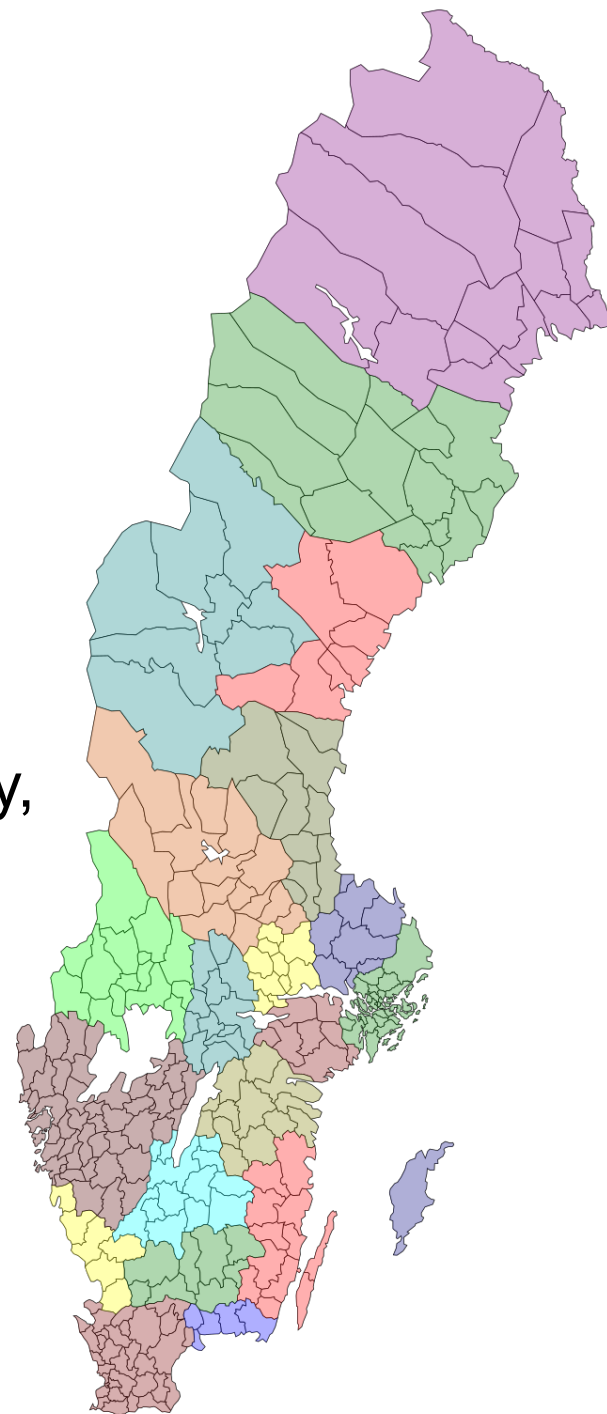

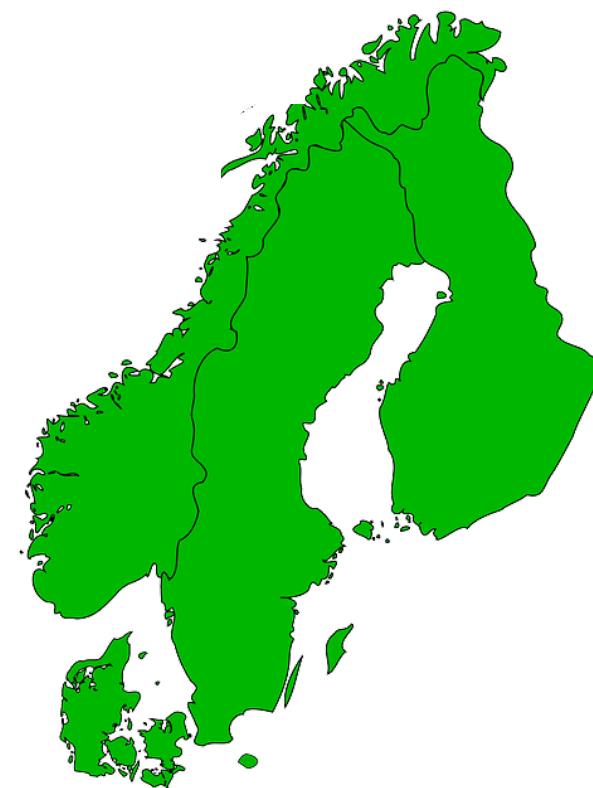
Sweden

Rescue services

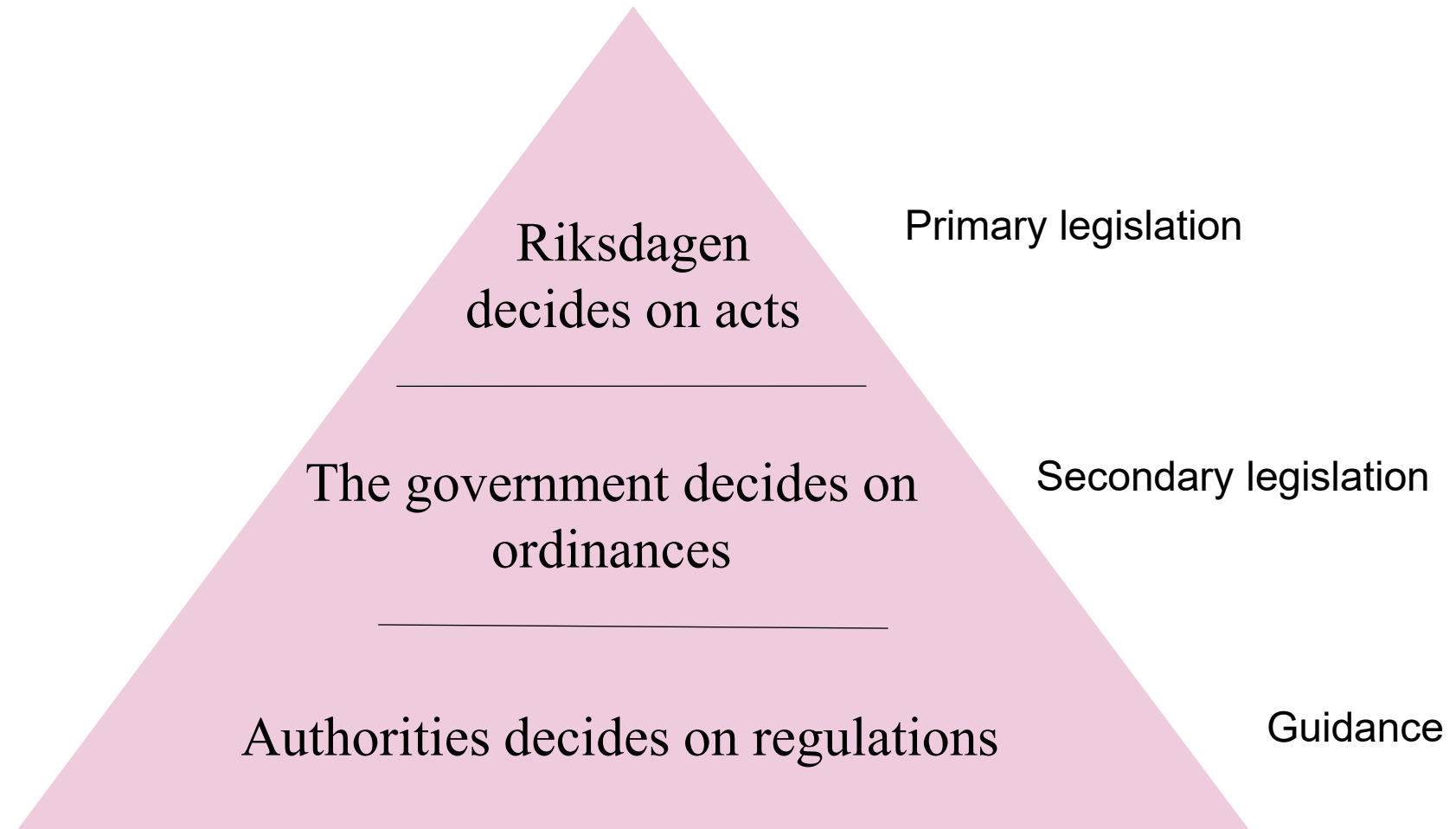


Upper and lower tier establishments in Sweden 2023

Obligations for authorities.....

- MSB is the competent authority
 - ➔ Implementation of Seveso III directive and TEIA convention
 - ➔ National authority for Seveso inspections
- 21 Regional authorities (county administrative boards):
 - ➔ Carry out Seveso inspections
- 290 Local Authorities (municipalities)
 - ➔ Responsible for external emergency planning
 - ➔ Responsible for information to the public
 - ➔ Responsible for land use planning
- 5 Courts
 - ➔ All upper tier establishments need an environmental permit
