

Roundtable on sustainable food systems - digitalization and food loss and waste reduction

14 November 2023, 15:00-18:00 (CET)

Background and context

To realize SDGs and deliver healthy and nutritious diets for all, the global food system needs to become more productive, inclusive, environmentally sustainable, and resilient.

The Secretary-General's Call to Action for accelerated Food Systems Transformation, issued ahead of the Food Systems Summit Stocktaking Moment (UNFSS+2) in July 2023, called on leaders to prioritize "incorporating food systems strategies into all national policies for sustainable development, for people's livelihoods, nutrition and health, for economic growth, climate action and nature, and to address post-harvest losses, leaving no one behind".¹

The 70th session of the United Nations Economic Commission for Europe (UNECE), held in April 2023 under the theme "*Digital and green transformations for sustainable development in the ECE region*" requested the relevant Sectoral Committees and their subsidiaries to "consider how to enhance the impact of relevant existing ECE instruments, in order to foster digital and green transformations". It invited subsidiary bodies to consider developing proposals in their respective programmes of work, including possible collaboration across subprogrammes, for impactful and measurable solutions that promote digital and green transformations and that can facilitate attaining the objectives of the 2030 Agenda for Sustainable Development.²

The UNECE Working Party on Agricultural Quality Standards has over the past few years focused on the prevention and reduction of food loss and waste, in support of Sustainable Development Goal (SDG) 12 Target 12.3 on halving food loss by 2030. The work has included the development tools and guidance documents, including the UNECE Code of Good Practice and the UNECE Food Loss and Waste Measuring Methodology for Fresh Produce Supply Chains, as well as awareness-raising events.

In response to the 70th Commission session and the UNFSS+2, this roundtable will discuss two aspects related to sustainable food systems: (i) food loss and waste prevention and reduction, and (ii) the role of digitalization in ensuring efficient agricultural trade, with a focus on the needs and solutions for national inspection bodies.

The discussions aim to inform Working Party deliberations on its future work.

	A third of all food that is produced ends up lost or wasted - around 14 % between

A third of all food that is produced ends up lost or wasted - around 14 % between harvest and retail, and another 17 % in households, food service and retail. This means that around 25% of the world's freshwater supply, and 8-10% of greenhouse gas emissions are used to grow food that ends up not being eaten. Reducing food loss and waste will thus be critical for increasing the sustainability and circularity of food systems, including for combating climate change, water scarcity and soil degradation. The Working Party has over the past few years developed several tools for food loss and waste reduction, including the UNECE Code of Good Practice to provide guidance to industry actors on reduce food loss and ensuring optimum handling of fresh fruit and vegetables along the value chain.³ This panel will share experiences about ongoing efforts on food loss and waste prevention and reduction.
