
Functional PRTRs in place in the Republic of Moldova with regular, good quality online reporting by operators;

- Governmental institution to create a functional mechanism for the information systems that assure access to environmental information, including PRTRs;
- Continuous improvements of the PRTRs in Moldova with regular, good quality online reporting by operators;
- Developing an Information campaign, informing the general public about the PRTRs and the type of data that can be accessed;

Continuous improvements of accessibility and availability of PRTR data and information for the public via PRTR websites;

Continuous Capacities development of PRTR authorities, operators and CSOs;

Updating university curricula on environmental emission information systems and training specialists about PRTRs;
