
## UNECE Industrial Accidents Convention



Sandoz spill, Schweizerhalle, Switzerland (1986)




# **Status of Ratification:** 42 Parties (including the EU)

# **Application of the Convention**

# **Scope of the Convention**

What kind of **accidents** are dealt with by the Convention?

- involving hazardous activities (manufacture, use, storage, handling, or disposal of hazardous substances)
- capable of causing transboundary effects

A list of **substances** and categories of substances is included in Annex I to the Convention. The annex was amended at the eighth meeting of the Conference of the Parties, December 2014, Geneva




#### **Examples of hazardous activities:**

- Fertilizers plants
- Chemical plants
- Oil storage facilities
- Tailings Management Facilities



Focus on governance and institutional structures: cooperation and coordination between authorities, industry & the public



# **Key obligations**

- Identification and notification of hazardous activities
- Development and implementation of policies, strategies and measures for:
  - **Prevention** of industrial accidents
  - Emergency preparedness
  - Emergency response, including industrial accidents notification & mutual assistance
- Information to and participation of the public



# Prevention: Transboundary cooperation

- Identification of hazardous activities capable of causing transboundary effects, including with Parties concerned
- Notification of existing or proposed hazardous activities capable of causing transboundary effects
- Establishment of policies on the siting of new hazardous activities and on significant modifications to such existing activities





#### Preparedness



- Emergency planning inside and outside industrial installations
- Emergency preparedness measures (Annex VII) pursuant to article 8, which requires development of transboundary emergency plans
- National emergency plans compatible with those of neighbouring countries to be able to respond to transboundary impacts
- The public should have an opportunity to participate in the preparation of prevention and preparedness measures, as well as have access to judicial proceedings to appeal a relevant decision (article 9)



#### Response

- Coordination of response within a country and between countries
- Industrial accident notification system
- The Convention encourages Parties to assist each other and cooperate in their response to industrial accidents, as well as in research & development and sharing of information & technology
- The Convention provides a platform for cooperation within and between countries and exchange of experience & good practices





#### Information to, and participation of the public

- Adequate information to be given to the public in areas capable of being affected by an industrial accident arising out of a hazardous activity
- Public to be provided with opportunity to participate in relevant procedures on prevention and preparedness
- Opportunity to be given to the public of affected Party to be equivalent to the public of the Party of origin
- Access to justice





## **Assistance and Cooperation Programme**

- Created in 2004
- Renamed and rebranded in 2018
- <u>Aim:</u> To support countries of South-Eastern and Eastern Europe, the Caucasus and Central Asia in the implementation of the Convention. The Programme's beneficiary countries increasingly provide assistance to each other









#### 12th meeting of the Conference of the Parties (CoP-12), Geneva, 29 November - 1 December 2022



Key COP-12 outcomes on Ukraine

- Welcomed **Ukraine** as the newest (42<sup>nd</sup>) Party to the Convention
- Parties and partners welcomed Ukraine and expressed their intention to support the country in strengthening industrial safety, seen as particularly important in the current context of the ongoing war
- **EIB** committed to provide enhanced inkind contribution, among others, to support activities to strengthen industrial safety in **Ukraine**
- 2023-2024 Workplan: Strengthening industrial safety, disaster risk governance and management in Ukraine to support implementation of the Industrial Accidents Convention

# Needs of Ukraine raised at COP-12

- ✓ ensuring power supply to hazardous installations;
- ✓ obtaining of special emergency and rescue equipment;
- ✓ receiving expert support to further align national legislation with the Convention;
- ✓ benefiting from technical missions to support implementation;
- ✓ continuing cross-border cooperation in basins, such as the Danube Delta;
- ✓ restoring critical infrastructure
- ✓ addressing urgent environmental protection problems, including in the Dniester basin

# Current and next steps

- ✓ Planned Projects with EIB: Receiving expert support to further align national legislation with the Convention
- ✓ Building on Ukraine's needs and UNECE available resources
- ✓ Discussed matter at the recent meeting of the Bureau
- ✓ Development of pool of potential project ideas (planning)

Ongoing UNECE-EIB Ukraine Project

- ✓ Receiving expert support to further align national legislation with the Convention;
- ✓ Report on analysis of the Ukrainian industrial safety legislation and its alignment with main requirements of the UNECE Industrial Accidents Convention
- ✓ Recommendations on how to harmonize and align the Ukrainian industrial safety legislation with the main requirements of the UNECE Industrial Accidents Convention;
- ✓ Roadmap to full implementation of the UNECE Industrial Accidents Convention

Line-up of potential future projects ✓ Overarching framework of project proposals: Supporting implementation of Industrial Accidents Convention through strengthening Ukraine's capacities to manage pollution from hazardous industrial activities, enhance industrial safety and strengthen resilience

#### ✓ Potential project idea 1

**Title**: Strengthen Ukraine's capacities to enhance management of contaminated sites, to prevent releases and enable the containment of industrial pollutants

#### ✓ Potential project idea 2

**Title**: Strengthen infrastructure and disaster risk reduction for mine tailings dams in the Dniester River Basin and beyond to protect communities and increase resilience

#### ✓ Potential project idea 3

**Title**: Enhance cross-border cooperation on the prevention of accidental water pollution and preparedness for industrial accidents in the Danube Delta
