## **Preamble**

On January the 25<sup>th</sup>, 2018, the University of Geneva (UNIGE) and the United Nations Economic Commission for Europe (UNECE) concluded a Memorandum of Understanding related to the promotion of the implementation of the 2030 Agenda for Sustainable Development as well as to the strengthening of their contribution to the achievements of the Sustainable Development Goals (hereinafter: the MoU).

The first MoU was concluded for 5 years commencing on January the 25<sup>th</sup>, 2018. On June the 4<sup>th</sup>, 2021, an addendum was signed pertaining to the establishment of a joint centre of excellence as well as to develop and undertake collaborative activities and projects to promote the principles of the Geneva UN Charter on Sustainable Housing through the Centre of Excellence.

This amendment aims to :

- Extend the duration of the Agreement
- Update the contacts at UNIGE

It is agreed by the Parties to modify the initial MoU signed on January the 25<sup>th</sup> 2018 by adding the following article:

### **Article 4A : Extension of the Agreement**

**(the original content of Article 4 remains valid and it is added the following article 4A to extend the MoU)**

According to the above article 4, paragraph 2 of the MoU, UNIGE and UNECE wish to extend the MoU for a period of 5 years. It shall be valid for five years as of the date of the final signature.

Any further extension to this MoU shall be made in a written agreement signed by the authorized representatives of the Parties. In the absence of extension, this MoU shall lapse at the end of five years.


