**10TH MEETING OF THE WORKING GROUP OF THE PARTIES (WGP 9) TO THE
PROTOCOL ON POLLUTANT RELEASE AND TRANSFER REGISTERS (PRTR) TO
THE CONVENTION ON ACCESS TO INFORMATION, PUBLIC PARTICIPATION IN
DECISION-MAKING AND ACCESS TO JUSTICE IN ENVIRONMENTAL MATTERS

EU+MS POSITION**

Agenda item 1: Opening of the meeting and adoption of the agenda

Final EU + MS statement

Good morning, in this first intervention on behalf of the EU and its Member States, we would like to thank the Secretariat for having prepared this meeting and for providing the relevant documents in a timely manner. We would also like to thank the Chairman for his words of welcome and for his introduction. We look forward to fruitful discussions over the next two days.

The agenda as proposed can be accepted by the EU and its Member States.

Agenda item 2: Status of ratification of the PRTR Protocol

Final EU + MS statement

The EU and its Member States would like to thank the Secretariat for the updated information provided on this item. With a view to ensuring the broadest possible public access to environmental information and facilitate the public participation in decision-making as well as contribute to the prevention and reduction of pollution of the environment, as set out in article 1 of the Kiev Protocol, it is crucial to promote a wider geographical applicability of this important international legal instrument and to enhance its status as a key multilateral environmental reporting instrument. For this reason, the EU and its Member States would welcome additional ratifications, including beyond the UNECE region. In particular, countries that are parties to other regional agreements on access to environmental information and/or PRTR systems could be encouraged to access the Protocol, for instance through awareness raising and promotional activities, possibly led by the UNECE or UN. In this regard, we warmly welcome the statement made by the delegation of Guinea-Bissau.

Agenda item 3: Promotion and coordination

Final EU + MS statement

The EU and its Member States would like to thank the Secretariat and all partner organizations for sharing information on relevant activities undertaken to promote the Protocol.

In this context, the EU and its Member States will continue to support promotion and coordination activities related to PRTRs, in particular with the Organization for Economic

Co-operation and Development (OECD), the United Nations Environment Program (UNEP), the United Nations Institute for Training and Research (UNITAR), other organizations and stakeholders. We particularly appreciate the work of the International PRTR Coordination Group in promoting the Protocol globally, as it could benefit from a more cross-cutting perspective.

Such cooperation is useful in identifying areas for improvement as well as in the development of PRTRs.

The EU and its Member States encourage the Secretariat and other partner organizations to continue to seek synergies, and welcome the Secretariat's initiatives to link with other treaties and conventions, as this will enhance the implementation of the Protocol.

Agenda item 4: Compliance and reporting mechanisms

Final EU + MS statement

The EU and its Member States thank the Secretariat and the Compliance Committee for their reports on their activities and take note of the information provided by the Secretariat on the next reporting cycle for the preparation of national implementation reports.

Agenda item 5: Subregional and national activities: achievements, needs and challenges

Final EU + MS statement

The EU and its Member States would like to thank all participants for sharing their experiences and progress made in implementing the Protocol and PRTRs, not only in the UNECE region but beyond as well. In this regard, we warmly welcome the statement made by the delegation of Cambodia. Once again, the EU invites all those countries that have a PRTR register in place to ratify the Protocol.

Agenda item 6: Fifth session of the Meeting of the Parties to the Protocol

Final EU + MS statement

The EU and its Member States would like to thank the Bureau for preparing this document, which is intended to be used by Parties and other interested States and stakeholders who wish to implement possible voluntary measures in order to facilitate implementation of decision IV/2.

*The overall objective and approach of the document captures **some of the practices and good experiences** in the development and implementation of PRTRs worldwide. In light of the progress and **experience gained since the entry into force of the Protocol in 2009**, the EU and its Member States find the proposal for a decision to develop and update the Protocol **timely** and **support the objective** to update the requirements of the Protocol.*

*The EU and its Member States **welcome** the document and **believe** it provides a relevant basis for further discussions. However, **because the process of reviewing the European Pollutant Release and Transfer Register Regulation is ongoing**, the EU and its MS propose to defer the discussion on the draft decision **to be in the position to provide a final opinion on the draft decision**. The EU would like to request the deletion from the draft decision of all references to the Regulation **pending its revision**.*

*Another point that the EU and its Member States would like to make, concerns plastic pollution. While recognizing the seriousness of the impact of plastic pollution on human health and the environment, we believe that **the discussion on promoting the inclusion of provisions on integrated PRTRs in the legally binding instrument on plastic pollution should be postponed** until the conclusion of the ongoing international negotiations.*

*Lastly, other aspects **such as the term “modernization”**, the concept of “integrated PRTR” or “single-window” or the meaning of “pollution and waste portals”, as they are currently referred to, are expected to be discussed in detail. Therefore, the EU and its Member States request to be given sufficient time to further analyze this draft proposal and to provide written comments.*

The EU and its Member States would like to thank the Secretariat for preparing this document related to the Work Program 2026-2029 for the Protocol on Pollutant Release and Transfer Registers and support the timeline foreseen for its development.
