The Advisory Group on Market Surveillance (MARS) was established in 2003 to be a forum for discussion about market surveillance, to increase transparency and visibility of the chain of control and to promote coherent best practices. MARS also finalized a *Revised Glossary of Market Surveillance Terms* (ECE/CTCS/WP.6/2022/4) in order to ensure that all relevant bodies are using the same terms in the same way. The revision adds a number of new terms that were not in use when the first version was developed as well as some updates to existing terms which have slightly evolved. The Group of Experts on Risk Management in Regulatory Systems (GRM) was established in 2011 as a high-level and international partnership in the field of risk management. The above report is presented to the Working Party for an endorsement decision.

GRM also finalized a revision of *Recommendation T on Standards and Regulations for Sustainable Development* (ECE/CTCS/WP.6/2022/6) which is presented to the Working Party for an approval decision. This recommendation has been updated to reflect key aspects of circular economy as outlined during the thirty-first session of the Working Party; all stakeholders of the Working Party were afforded an opportunity to provide comments to this revision.

Common Regulatory Framework ECE/CTCS/WP.6/2022/INF.4 For information for Equipment Used in Environments with an Explosive Atmosphere

The Ad Hoc Team of Specialists on Standardization and Regulatory Techniques (START) was established in 1999 with an aim to assist member States' efforts to converge towards better regulations. This includes the reduction of non-tariff barriers to trade and harmonizing the content of technical regulations in key sectorial areas such as equipment for explosive environments and pipeline safety. Special focus is given to support efforts by schools, universities, vocational training institutions and other training and research establishments to integrate standards and standards-related issues in their curricula. The above report is presented to the Working Party for an endorsement decision.

The Common Regulatory Framework for Equipment Used in Environments with an Explosive Atmosphere in document ECE/CTCS/WP.6/2022/INF.4 was developed and finalized in 2019 but had not yet been presented to an annual session. It is a second edition to the document ECE/TRADE/391. It is presented for information.

The initiative on education on standardization (START-Ed) also proposes the establishment of a network of focal points from academia in order to further promote and disseminate education on standardization (annex 1 to document ECE/CTCS/WP.6/2022/7). This responds to the recommendations formulated in the December 2019 Evaluation of Working Party 6<sup>1</sup> to create a group in support of this initiative.

At the thirty-first session of WP.6, it was requested to establish a Team of Specialists on Gender-Responsive Standards (GRS), to follow up on the initiative established in 2016. The objective remains to mainstream gender in the activities and management of standards developing bodies. The above report is presented to the Working Party for an endorsement decision.

The Gender-Responsive Standards Initiative (GRSI) has completed a *Guidelines on Developing Gender-Responsive Standards* (ECE/CTCS/WP.6/2022/9). This methodology document provides practical steps that standards development bodies can take to ensure that their standards are gender-responsive and that there is satisfactory gender inclusion in standards development. This document is intended to become an official publication; it is presented to the Working Party for an endorsement decision.

The phase II of the project on Standards for Sustainable Development Goals (SDGs) comes to a close in 2022. The secretariat is pleased to report being on target for all of the deliverables planned within the project. The report provides an outline of the key achievements since 2021. Two of the achievements include the training materials also presented under this agenda item. The secretariat further draws the attention to two platforms developed under this project. The Standards4SDGs platform<sup>2</sup> has been enhanced in this period, now containing over 20,000 standards mapped to all of SDGs. The second platform hosts elearning modules linked to quality infrastructure and will support accessibility of all to such information as well as support the WP.6 START-Ed model curricula on education on standardization. These documents are presented to the Working Party for information.

In December 2019, an evaluation of Working Party 6 proposed<sup>3</sup> that the Working Party review and update its *Terms of reference*<sup>4</sup> in line with the *Guidelines for the establishment and functioning of working parties within ECE* (ECE/EX/1, paragraph 3(d)) to assess and propose necessary adjustments to the mandate and status of WP.6. The evaluation further suggested that this review reflect as appropriate the priorities of the 2030 Agenda. The thirty-first session requested the Bureau to draft a revised terms of reference for consideration and
